## Amendment: Order Form and Products and Services Agreement

With respect to the Order Form with a start date of 1 April 2023 between PressReader International Limited (**PressReader**) and National Library of Czech Republic (**Client**), the parties agree to amend and modify the Products and Services Agreement (**Agreement**) as follows:

1. **Definitions:** In addition to the defined terms set forth in the Agreement, the following terms have the following meanings:
  - (a) **Agent** means [REDACTED]
  - (b) **Member Organizations** means those libraries, institutions or organizations who form part of the Client consortium and are eligible to receive the PressReader Products and Services under the Agreement.
2. **Member Organizations:**
  - (a) The Client represents an informal consortium of Member Organizations, who are eligible to receive PressReader Products and Services under the Agreement, subject to payment of the fees associated with such PressReader Products and Services.
  - (b) The current list of Member Organizations is attached as Schedule A to this Amendment. The Client may add Member Organizations at any time during the Term, upon written notice to PressReader, and PressReader will deliver the PressReader Products and Services to the new Member Organization, subject to payment of the fees associated with the PressReader Products and Services to be delivered.
  - (c) The Client shall remain responsible for each Member Organization's use of the PressReader Products and Services and each Member Organization's compliance with the terms of the Agreement.
3. **Payment to Agent:**
  - (a) The Parties agree that PressReader's Agent is authorized to accept, on PressReader's behalf, any fees payable to PressReader with respect to the PressReader Products and Services delivered to the Client and/or the Member Organizations.

- (d) The Agent shall issue a tax document within 10 days of receiving the applicable payment from the Client.




**4. Special arrangements:**

- (a) The Parties acknowledge and agree that the Client and the Member Organizations have received funding for the PressReader Products and Services from the Czech Republic Ministry of Culture (**Ministry of Culture**), and that for the period of the Term commencing April 1, 2023, and ending November 30 2023, PressReader will accept payment from the Ministry of Culture with respect to the PressReader Products and Services delivered to the Client and the Member Organizations, provided, however, that the Client remains responsible for ensuring payment is received by PressReader with respect to the PressReader Products and Services, and any failure by PressReader to receive payment will be a material breach of the Agreement by the Client. The portion of fees payable with respect to PressReader Products and Services delivered from December 1, 2023 to March 31, 2024, will be paid by the Client and/or the Member Organizations.
- (b) PressReader accepts this agreement will be published in a Register of Contracts according to Act No. 340/2015 Coll., Act on the Register of Contracts. However, PressReader consider pricing and service specifications as a subject of business secrecy within the meaning of Section 504 of the Civil Code and therefore excludes pricing and service specification from disclosure, and requires concealment of information about pricing and service specification in the electronic image of the text content of the contract, which client have to send to registry administrator for publishing. The Client hereby agrees and undertakes to keep confidential information about pricing and service specifications as the business secret at least until the decision of the superior authority of the client or court decides that the unpublished part of the contract should be provided according to the regulations regulating free access to information.


