

AMENDMENT No. 1

Amendment No 1 to the Consortium Agreement

Article 1 – Purpose of the Agreement

After the Effective Date, four of the Parties:

- **BIOMEDICINSKE CENTRUM SLOVENSKEJ AKADEMIE VIED, VEREJNA VYSKUMNA INSTITUCIA (BMC SAV)**
and
- **SEMMELWEIS EGYETEM (SU)**
and
- **SVEUCILISTE U ZAGREBU MEDICINSKI FAKULTET (UZSM)**
and
- **UNIVERSYTET MEDYCZNY W LODZI (MUL)**

have changed their bank accounts.

The purpose of this amendment is to update bank account information specified in the **Attachment 6: Consortium Plan – Distribution of payments, Section 6.3** as for the above named Parties.

The amendment of Section 6.3 of the Attachment 6 has no influence to the Consortium Plan and so it does not require a decision of the Board as presumed in Article 6.3.1.2 of the Consortium Agreement.

A change of a Party's bank account shall be at sole discretion of the relevant Party. Also, no Party shall be directly or indirectly affected by change of a bank account of another Party (save a change of the Coordinator's bank account). Nevertheless, in accordance with Section 11.1 in connection with the Section 11.4 of the Consortium Agreement, amendments and modifications to the text of the Consortium Agreement not explicitly listed in its Section 6.3.1.2 require **a separate written agreement to be signed between all Parties.**

Article 2 – Amendment of the Attachment 6, Section 6.3

Parties agree to amend the **Attachment 6: Consortium Plan – Distribution of payments** in its Section 6.3 as follows; Sections 6.1 and 6.2 remain unchanged.

The transfer of this copy by e-mail or via an electronic signature system will have the same legal force and legal effect as the transfer of the original copy of the Agreement.
