

CONTRACT THE PERFORMANCE "BARBIAN" AT ABC THEATRE (PRAGUE CITY THEATRES) IN THE FRAMEWORK OF THE QUADRENNIAL 2023

this agreement settles the terms and ways of collaboration between ACE and the Prague City Theatre for the realization of the tour of the performance "Barbián", by Fernando Carmena, starring Rodrigo Cuevas at the venue of Prague City Theatres on June 14, 2023, according to this schedule:

- June 14, 2023: arrival of the Company
- June 14. 2023 at 20.00 Performance

1.AC/E will guarantee the presence of the Company, the realization of the performance, the Czech house program layout as well as the print costs.

2.AC/E, directly or by virtue of the collaboration agreement signed with the other Spanish institutions organizing the representation of Spain at the Prague Quadrennial 2023, will take directly in charge:

- travels and accommodation in a first category hotel with breakfast close to the theatre, and the local transfers for the company.
- the interpreters during the stay, the set-up, the performance.
- communication, the house program Czech translation.

3.The Prague City Theatres will take directly in charge:

- the cost of the running of the theatre, including front and back house personnel.
- the **technical rider** (materials, technical equipment, and technicians) as agreed with ACE which is part of this contract (schedule).
- The Rentals of technical equipment will be paid by the institutions in charge of Spanish participation in PQ 2023 directly thru the invoice.
- The box office income of the performance remains to the Theatre. Ticket prices will be at the usual ABC Theatre rate of 350/300 CZK.
- The PCT will pay author and music rights through the Czech society DILIA, a.s

4. Advertising and Communication

All advertising and communication will be agreed between AC/E and the PCT. Each part will respect the indications provided according to the Schedule and will insert in all material the logos of ACE and the institutions in charge of the Spanish participation at the PQ 2023 as in the Schedule A.

5. Force Majeure

This contract will be canceled in case of force majeure circumstances such as flood, fire, earthquake, explosion, storm, epidemic and other natural calamity, wars, terroristic attacks, military operations, prohibitory acts of the government and state authorities, national strikes, civil disturbances, insurrections, invasion, or any other circumstances beyond the control of the Parties. The illness of Rodrigo Cuevas, who is unreplaceable, will be considered Force Majeure. In case of Force Majeure, if the company is already in Prague, the Embassy cover anyway the hotel accommodation and the travel back of the company.

Apart from force majeure circumstances, any cancellation by the parts will have the obligation to reimburse the other parts for all expenses incurred prior to the date of cancellation.

If the parts commit any breach of any of the terms and conditions of this agreement or of the conditions endorsed hereon, the executor, without prejudice to other remedies aforesaid, may forthwith determine this agreement and the defaulting parties shall have no claim for any payment whether by way of remuneration for services, expenses, or costs. The Parties will do their best to settle all disputes and disagreements by peaceful negotiation. This agreement contains the entire understanding of the parties relating to the subject matter hereof superseding all prior communications between the Parties, whether oral or written.

6. Termination and Amendment

This agreement may not be altered, amended, modified, or otherwise changed, nor may any of the terms hereof be waived, except by an instrument in writing signed by all parties. This agreement is compiled in English in 3 (three) copies which are identical in their content, and it is valid only with the attached Schedules:
