#### Article 1 - DURATION OF THE PROJECT

Entry into force of the grant decision and duration

The actions shall be carried out between 01-01-2023 and 30-06-2024.

Each project partner accepts the work plan of the Application Form and respects the timetable of the events to be co-organized by the partners involved.

#### **Article 2 – COOPERATION**

Partners undertake the obligation to participate in the project events with the minimum participants listed in table 1

## **Article 3 – PARTICIPANT DISTRIBUTION**

The partners undertake to send participants to the events to be held in the five proposed countries; the number of delegates to each event abroad is determined and shown in *Table 1: Participation in meetings*.

The details of the participants, as well as those concerning the booking of their flights and booking of the accommodation, must be sent to the applying partner at least 45 days before the opening of the international event.

If a member is unable to send any participants to an event, it is his/her duty to inform the Padrón City Council about this situation at least 40 days before the meeting and help to find substitute person(s) who can be registered in the list of attendees as international attendees.

## **Article 5. FINANCIAL CONDITIONS**

The partners accept that the promoting partner, Municipality of Padrón, will carry out the integral management of the organisation and the activities foreseen in the project.

Partners are obliged to help manage and participate in events under the following rules:

- TRAVEL EXPENSES of participants from the airport of departure and to the airport of arrival for the event nº1 and event nº 5 will be purchased directly by the project applicant (Municipality of Padrón).
- THE PROJECT PROMOTING PARTNER (Municipality of Padrón) will make a bank transfer to all project partners in the amount of 1.000€. Eligible costs are:
  - Transfers (any mean of transport) for events II, III and IV
  - Accommodation, meals, transfers of extra participants appointed by the participating partners
  - Single rooms for participants listed in table 1
  - Dissemination of the project (creation of videos...)
  - Preparation of the participants taking part (trainings, materials to create presentations etc.)

All partners must send invoices for the expenses which are eligible after each event, as part of the justification in case of ex-post audits by EACEA.

- the ACCOMMODATION COSTS of the funded participants (as stated in table 1) and the costs for the organisation of the meetings will be fully covered by the project promoter partner (Municipality of Padrón)

Single rooms may be requested by the participant who wishes to do so, paying a supplement per day/night (duly informed in advance about the costs and eligible to cover with the allocated funds).

-ACCOMMODATION costs will only cover the accommodation of foreign participants (3 nights). Each event must be attended by representatives of each entity, as listed in table 1.

The ORGANISATIONAL COSTS will be paid by the project partner (Municipality of Padrón) and include the cost of local transport from the hotel to the scheduled meetings, catering costs for foreign participants (3 lunches and 2 dinners), and programme costs (e.g. conference fees, preparation of programme material, speakers and lecturers, conference rooms, logistic costs, the elaboration of common communication products, (Spots, Analyses, etc.)

The CITIZENS, EQUALITY, RIGHTS AND VALUES PROGRAMME (CERV) requires official INSURANCE for participants in international meetings. The promoting partner (Municipality of Padrón) will arrange the corresponding travel and civil insurance for the participants for ALL THE EVENTS.

The local transfer of the participants from their home to the airport of departure and vice versa, as well as from the airport of arrival to the accommodation and vice versa, will be at the expense of the participant(s) or arranged by using the allocated money of 1.000€ (duly justified).

## **Article 6. ABSENCE OF PARTICIPANTS**

If a partner does not comply with his obligations to send participants to the project meetings abroad, all financial consequences must be assumed by itself, and the proportional amount of money, obtained from the payment must be returned to the project promoter (Municipality of Padrón).

If a foreign participant is replaced by another participant, once the transfer ticket is acquired, the amount of the expenses of the new travel ticket will be paid by the partner who manages the substitution.

#### **Article 7. COORDINATION OF CONFLICTS**

The partners accept that any conflicting situation and a question related to the implementation of the project must be managed through the project leader and that all project partners commit to carrying out the actions provided for in the project

## **Article 8. DISSEMINATION**

The partner organization will disseminate information through the existing social networks reflecting the funding received by the European Union. The information will be sent by the promoter organization at the end of each of the events.

## **Article 9. FINAL REPORT**

The "partner organization" will upload the program of activities carried out during the 5 events on the official website (or Facebook if there is no website) of the entity. Furthermore, the "partner organization" will provide the necessary documents to prove that the activities were implemented by replying to the evaluation forms

## **Article 10. BANK TRANSFER**

The project promoter (Municipality of Padrón) will make a single bank transfer to each of the 16 partner entities of 1.000€. This bank transfer will be made after collecting this agreement. It shall include a bank certification matching the name of the participating partner.
