- 1.4 The price specified in subclause 1.1 above is the agreed full uniform price, which includes the basic price, other surcharges, fees for additional services, and discounts that may be claimed by the Sender, including the discount for economy delivery option for economy consignments. Additional services, discounts and services that are subject to surcharge according to the Pricelist, other than those listed in subclause 1.2 and 1.3 above will not be provided to the Sender. The Sender is not entitled to demand additional services or services that are subject to surcharge according to the Pricelist, other than those set out in subclause 1.2 and 1.3 above. No other discounts can be claimed for this price.
- 1.5 The compliance with the parameters for OL consignments specified in subclause 1.2 above will be verified against the posted consignments handed over by the Sender. The box labels of posted consignments will include the number of posted consignments.
- 1.6 The compliance with the parameters for LF, RR consignments specified in subclause 1.3 above will be verified against the posting data.
- 1.7 The price set in subclause 1.1 above applies if more than 100,000 OL and LF, RR consignments have been sent during the Period set in subclause 1.1 above. If this condition is not met, the price set in subclause 1.1 above for the Period will be retroactively increased by ČP to the basic price for OL and LF, RR consignments of the same weight set in the Postal Terms and Conditions of Česká pošta, s.p. Pricelist of Basic Postal Services and Other Services valid as of the day of handover of individual consignments. The difference between the price for the OL and LF, RR consignments exclusive of VAT

set in subclause 1.1 above and the price for OL and LF, RR consignments of the same weight set in the Postal Terms and Conditions of Česká pošta, s.p. - Pricelist of Basic Postal Services and Other Services valid as of the day of handover of individual consignments will be invoiced by ČP together with VAT at the current rate. ČP will issue the invoice (debit note) with a from the date of issuance and send it to the Sender.If the conditions set in subclause 1.5 and 1.7 above are met but the parameters in the lists of posted consignments do not comply with those set in subclause 1.2 and with those set in subclause 1.3 above, ČP will calculate a new price based on the parameters in the lists of posted consignments or in the posting data and subject to the following conditions:

- If the new price is within the tolerance limits of ± 3.5 % of the original price, the original price will apply;
- If the new price is not within the tolerance limits of \pm 3.5 % of the original price, the Sender will be informed about the new price and:
 - a. will enter into a negotiation with ČP to conclude an amendment for the new price and charge the difference between the new price and the original price for the total number of consignments posted in the previous period by means of an invoice (debit note);
 - the original price will continue to apply and the Sender will be informed about the non-compliance with the agreed parameters.

At the end of the Period, ČP will calculate a new price based on the parameters from the lists of posted consignments for the entire Period, and will issue an invoice (debit note) for the difference between the new price and the original price for the total number of consignments posted in the Period.

The new price negotiation should be started at least 1 month before the expired date, and sign a supplementary agreement for the new price.
