

**AMENDMENT NO 3 TO THE
RESEARCH COLLABORATION AGREEMENT**

BETWEEN

**CZECH TECHNICAL UNIVERSITY IN PRAGUE, FACULTY OF MECHANICAL
ENGINEERING**

AND

GE AVIATION CZECH S.R.O.

This Amendment No. 3 to the Research Collaboration Agreement (the “**Amendment**”) is made on the dates set forth in the signature blocks below to be effective as of the date of the last Party to execute this Agreement (the “**Effective Date**”) by and between **CZECH TECHNICAL UNIVERSITY IN PRAGUE, FACULTY OF MECHANICAL ENGINEERING**, a technical university organized and existing under the laws of the Czech Republic (“**CVUT**”), and **GE AVIATION CZECH s.r.o.**, a limited liability company, organized and existing under the laws of the Czech Republic (“**GEAC**”) (CVUT and GEAC are also referred to individually as “**Party**” and jointly as “**Parties**”).

RECITALS:

- A) On October 14, 2016 the Parties signed a Research Collaboration Agreement, as amended (the “**RCA**”).
- B) Following the discussion and evaluation by the Parties GEAC agreed to provide financial Contribution to CVUT (in addition to the GEAC Financial Contribution per Schedule 2 of the RCA) to support mutual efforts in pursuing Research Project goals.

In consideration of the covenants contained in this Agreement, the Parties agree as follows:

ARTICLE 1 - DEFINITIONS

- 1.1 In this Amendment, unless the context otherwise requires, the expressions used have the same meaning as in the RCA.

ARTICLE 2 – ADDITIONAL GEAC FINANCIAL CONTRIBUTION

- 2.1 In accordance with Article 3.2 of the RCA, GEAC agrees to provide an additional GEAC Financial Contribution in the amount of _____ CZK to CVUT to be applied towards the costs associated with the Research Project. Additional Financial Contribution according to the previous sentence will be provided to CVUT within 7 days since effectiveness of this Amendment at latest.

ARTICLE 3 - MISCELLANEOUS PROVISIONS

- 3.1 Amendment.** This Amendment represents a change of rights and obligations of the Parties to the RCA. Unless expressly stated otherwise or following from this Amendment, this Amendment changes no other provisions of the RCA, the RCA remains valid and effective as amended by this Amendment.
- 3.2 Counterparts.** This Amendment may be executed in two or more identical counterparts, each of which shall be deemed an original and all of which taken together shall be deemed to constitute the Amendment when a duly authorized representative of each Party has signed a counterpart.

The Parties have caused this Amendment to be executed in duplicate originals by their duly authorized representatives on the dates set forth below to be effective as of the Effective Date.
