

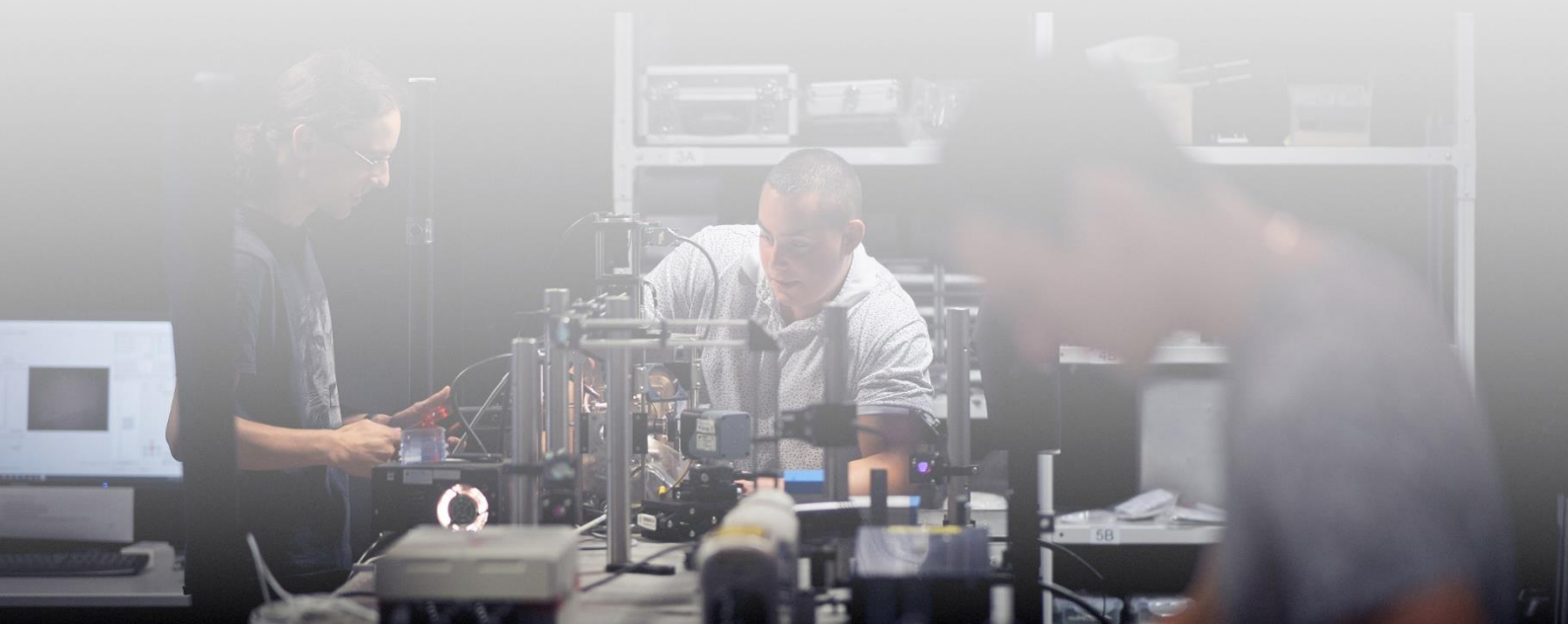

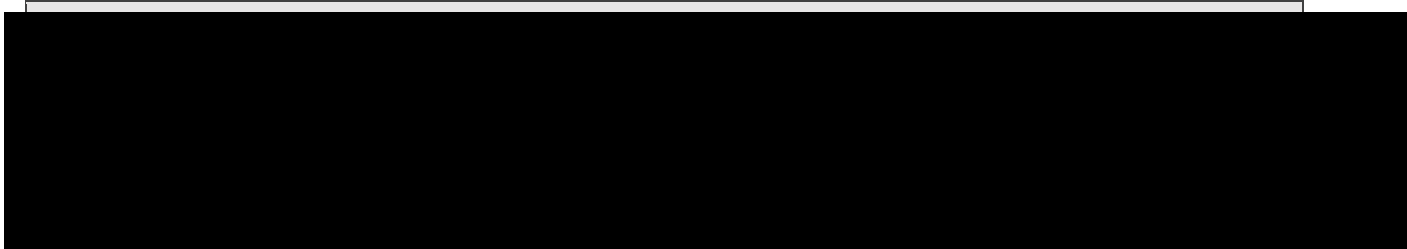

Delivery time

The delivery time is specified in milestones, standard delivery time is 6 months.

Guarantee

The guarantee period is **12 months** starting on the day of acceptance of the instrument. Longer warranty period can be obtained upon request.

Service

Initial diagnostics is provided by the Lightigo (Brno, Czech Republic) remotely, utilizing Windows Remote Desktop, Skype, Teams, or by e-mail. The potential failure of individual components is solved by the exchange of whole modules, which can be dismantled/mounted by the customer. In a case of more complicated issues, the service is provided by the Lightigo on site.

IP protection

The subject of delivery is a prototype, control firmware and software (together "Development Product") developed on the basis of Lightigo's know-how. This Development Product is used to test the optical shaping of laser pulses. The Development Product, or parts thereof, and information about it (documentation, performance, source code, etc.) will not be disclosed to 3rd parties without the consent of Lightigo, whose exclusive ownership of this IP remains.
