# **CONTRACT AGREEMENT**

and

**Evans & Sutherland Computer Corporation**

hereinafter referred to as the "**Contractor**", represented by Mr Kirk Johnson

have signed the Contract under the following terms and conditions:

## **Article 1**

The Employer hereby commissions the Contractor to design, execute and complete the Works, and remedy any defects therein, for the Employer to be located at Královská obora 233, 170 21 Prague 7, Czech Republic.

## **Article 2**

In this Contract the words and expressions shall have the same meanings as are respectively assigned to them in the Contract for Plant and Design-Build Construction Works – General Conditions as mentioned in the Article 3.

## **Article 3**

The following documents shall be deemed to form and be read and construed as part of the Contract:

- (a) the Contract Agreement,
- (b) the Letter of Tender with Schedule of Payments and the Appendix to Tender,
- (c) the Particular Conditions,
- (d) these General Conditions,
- (e) the Employer's Requirements,
- (f) the Contractor's Proposal, and
- (g) any other documents forming parts of the Contract.

These documents are to be taken as mutually explanatory of one another, with their priority as stated above.

#### **Article 4**

In consideration of the payments to be made by the Employer to the Contractor as hereinafter mentioned, the Contractor shall design, execute and complete the Works and remedy any defects therein, to be fit for purpose in conformity with the provisions of the Contract for Plant and Design-Build Construction Works.

#### **Article 5**

The Employer shall pay the Contractor, in consideration of securing of design, execution and completion of the Works and remedying of any defects therein, the lump sum of

or such other sum as may become payable under the provisions of the Contract for Plant and Design-Build Construction Works at the times and in the manner prescribed by such Contract.

#### **Article 6**

The payment specified in the Article 5 does not include VAT tax. VAT tax will be added in accordance with the regulations of the law in the Czech Republic.

#### **Article 7**

The Parties agree to publish the Contract in accordance with Act No. 340/2015 Coll., the Act on the Register of Contracts, as amended. Publication shall be ensured by the Employer.

#### **Article 8**

This Contract is concluded on the day of signing by both Parties and enters into force on the day of publication in accordance with the article 7.

#### **Article 9**

This Contract shall be governed by and construed in accordance with the laws of the Czech Republic.
