 iv. GIVEN that the provisions contained in the Agreement and any previous Agreement Amendment(s) remain valid and in effect, except as revised by this Agreement Amendment.

**THE PARTIES HAVE AGREED:**

## Article 1 – Revised Items

1.1 The Parties agree to the revision of the Agreement to address the emerged needs and make necessary modifications to the Project. The applicable changes under this Agreement Amendment are set out in the Revised Information Schedule in Appendix 1 to this Agreement Amendment, unless specified otherwise, and consist of:

The General Conditions of Contract for Bilateral, Tripartite and Government Project Partnership Agreements may not be modified without the approval of the UNHCR Implementing Management and Assurance Service, and UNHCR Legal Affairs Service.

## Article 3 – Agreement Amendment

3.1 This Agreement Amendment:

- a. adopts the definitions as specified in the Agreement; and
- b. shall, together with the Project Partnership Agreement (and as amended previously), constitute the entire agreement between the Parties in relation to the subject matter of the Agreement, and a copy of this Agreement Amendment shall be attached, or shall be deemed to be attached, to each original of the Project Partnership Agreement; and
- c. shall be effective as of the date it is signed by the Parties so that, at any time thereafter, the Agreement shall be read and interpreted subject to and in accordance with the amendments contained in this Agreement Amendment.

3.2 In all other respects, the terms and conditions of the Agreement remain unaltered.

## Article 4 – Language

This Agreement Amendment may only be signed in one of the following three languages: English, French or Spanish. An unofficial translation in another language can be attached to the official language version only in exceptional situations. If an unofficial translation is attached to the Agreement Amendment, it shall be clearly labelled and treated as an unofficial translation. In the event of any dispute or controversy in the interpretation of the Agreement Amendment, the English/French/Spanish version shall prevail.

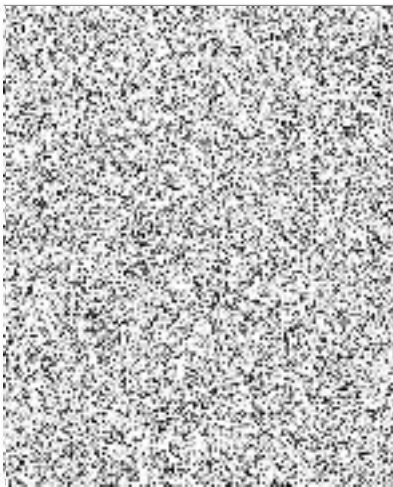
