(jointly referred to individually as a "**Party**" and together as the "**Parties**")

hereby enter into this service agreement (hereinafter as "**Agreement**").

1. PREAMBLE

- 1.1 The Parties enter into this Agreement for the purpose of specifying the services provided by the Provider, consisting in particular in the providing of the Broaddy service (hereinafter as "**Service**").
- 1.2 The terms and conditions of the Provider (hereinafter as "**Terms and Conditions**"), which form Annex 1 to this Agreement, shall be an inseparable part of the Agreement from the moment of its entering into effect.

2. RIGHTS AND OBLIGATIONS

- 2.1. The Agreement is concluded for the period from 1.1.2024 to 31.12.2024 (hereinafter as "**Period**").
- 2.2. The Parties agree that the Provider shall provide the Client with the Service at the price of 100.000,- CZK (one hundred thousand Czech crowns) per Period (hereinafter as "**Price**").
- 2.3. The Price will be paid as a one-time payment based on an issued invoice.
- 2.4. The Client will be provided with:
 - 2.4.1. 1 (one) administrative access for the Client to the Broaddy Administrative Interface (a CRM platform with specific functions related to a university Buddy programme with access to the database of the authorized users registered under the Client's institution into the Broaddy Web App and/or Mobile App) (hereinafter as "**Administrative Licence**").
- 2.5. The users (students of the Client and participants of the Buddy programme) will be provided with free access to use the Broaddy Web App and/or Mobile App (a separate web or mobile

phone-based application provided by the Provider allowing university students to inter alia register and connect with each other in the so-called Buddy programme).

- 2.6. The Parties further agree that the Provider shall provide specific users (agreed with the Client on the details of such persons) with 7 (seven) additional Administrative licenses at a price of 7.000,- CZK (seven thousand Czech crowns) per one additional Administrative license per Period.

4. FINAL PROVISIONS

- 4.1. The Parties hereto respectively represent and warrant that they have the full legal right and authority to enter into this Agreement, to perform any obligations undertaken pursuant to this Agreement, and that the persons signing on their behalf are legally authorized to do so.
- 4.2. This Agreement will come into effect as of the date of signature by all the Parties hereto, it being understood that if the Agreement is signed on different dates, the date to take into account is the most recent. The Agreement becomes effective on the date of its publication in the Czech Contracts Register in accordance with No. 340/2015 Coll., on special conditions for the effect of some contracts, the publication of such contracts and the register of contracts (the Contracts Register Act), as amended. The Parties expressly stipulate that Charles University assumes responsibility for publication of this Agreement in the Contracts Register in line with Act No. 340/2015 Coll., as amended.
- 4.3. If one or several provisions of this Agreement are declared void, this shall not affect the validity

of the remaining provisions of the Agreement. Void provisions shall be substituted by provisions which are valid, and which most closely correspond to the aim and purpose of this Agreement including the void provision.

- 4.4. This Agreement may not be modified or amended, and no provision may be waived, except as agreed by both Parties in writing.
- 4.5. This Agreement is the entire agreement between the Parties with respect to the subject matter hereof and supersedes all prior agreements, whether written or oral.
