- 1.1 The Parties to the Agreement agree to change the content of Agreement on the Conditions for Posting Business Letter Consignments No. 2022 / 00534 dated 30.6.2023, as follows:
- 1.2 The Parties have further agreed to replace the entire existing provision of clause 5 subclause 5.3 with the following text:
- 1.3 The logistics service fees shall be settled when
- a) in the case of Business Letter - Registered consignments the status of the Consignment indicated in ČP System becomes "21", "22", "23", "24", "25", "5S", "-F", "01", which means status "GTMS-ACCEPT" in XXXXXXXX System, and a corresponding invoice shall be generated,
 - b) in the case of Business Letter after verifying the list of all posted consignments and a corresponding bill shall be generated.

2. Closing provisions

- 2.1 The other provisions of the Agreement remain without change and in force.
- 2.2 This Amendment No. 1 is made on the day of its signature by both Parties to the Agreement.
- 2.3 This Amendment is made in two counterparts with the force of an original, each Party to the Agreement will obtain two counterparts.
