**II.**

1. In accordance with the article XIV paragraph 1 of the Framework Agreement for the production and supply of intaglio inks for alcohol tax stamps (No. 045/OS/2022) concluded on 17. 2. 2023 (hereinafter this version referred to as the "**Framework Agreement**") the Contracting Parties have agreed upon:

a) article I section "Buyer" of the Framework Agreement is replaced by the following:

b) the Annex No. 1 of the Framework Agreement: Price list, is replaced by the Annex No. 1 to this Amendment No. 1.

c) article IV paragraph 3 of the Framework Agreement is replaced by the following:

„3. The Seller is obliged to deliver the Goods to the Buyer’s production plant at the address:

d) article IV paragraph 12 of the Framework Agreement is replaced by the following:

„12. Each pallet with Goods shall be designated as follows:

110 00 Praha 1 - Nové Město  
Czech Republic“

2. The Buyer and the Seller concluded the Order No. S230138 made on 19<sup>th</sup> September 2023 and accepted by the Seller on 19<sup>th</sup> September 2023 (hereinafter referred to as “Order No. S230138”). The Contracting Parties agreed that on the date of taking effect of this Amendment No. 1, the provisions of this Amendment No. 1, resp. the Annex No. 1 of this Amendment No. 1, be applied to the obligations arising from the Order No. S230138.

3. The other provisions of the Framework Agreement and its Annexes shall remain unchanged and in full force and effect.

### III.

1. This Amendment No. 1 comes into validity on the day of signature by both Contracting Parties and into effect after disclosing in the Contracts Register in accordance with the Register of Contracts Act.
2. The Parties take into consideration that in accordance with Section 219 (1) (d) of the PPA, this Amendment shall be published in the Register of Contracts pursuant to Act No. 340/2015 Coll., laying down special conditions for the effectiveness of certain contracts, the disclosure of these contracts and the register of contracts (the Register of Contracts Act), as amended. The publication shall be arranged by the Buyer.
3. This Amendment is drawn up in electronic form, with both Contracting Parties receiving its electronic original with qualified electronic signatures of the responsible person and with a qualified electronic time stamp in accordance with REGULATION (EU) No 910/2014 OF THE EUROPEAN PARLIAMENT AND OF THE COUNCIL of 23 July 2014 on electronic identification and trust services for electronic transactions in the internal market and repealing Directive 1999/93/EC and Act No. 297/2016 Sb., on trust-creating services for electronic transactions, as amended later regulations. In the event that this Amendment is not drawn up in electronic form for any reason, it will be drawn up and signed in two copies, with each of the Contracting Parties receiving one copy.
