

**2023-1-CZ01-KA121-VET-000115997 CONTRACT for a training placement in  
KA121 — mobility in vocational education and training**

Under the Erasmus+ Programme

By signing this document the sending institution and the host organisation confirm that they will abide by the principles of the Training Agreement for Erasmus student placements set out in the document below.

The sending institution and host organisation jointly undertake to negotiate and agree a tailor-made Training Agreement (including the programme of the placement and the recognition arrangements) for each student and the adequate mentoring arrangements.

**CONDITIONS**

**1 ARTICLE 1 - PURPOSE OF THE CONTRACT**

- 1.1. The sending institution will provide Community financial support to the participant for undertaking a Training Placement under the KA121 — mobility in vocational education and training of the Erasmus+ Programme and will pay for the services indicated in this contract to the host institution. Project number: 2023-1-CZ01-KA121-VET-000115997.
- 1.2. The host institution undertakes to carry the services referred to in this Agreement in the Article 4 — Payment Arrangements in accordance with Erasmus+ learning agreement complement.

**2 ARTICLE 2 - DURATION**

- 2.1. The contract shall enter into force on the date when the last of the two parties signs.
- 2.2. The preparatory visit shall start in March 2024 /from 11th March to 15th March 2024/
- 2.3. The date of traineeship: **from 2<sup>nd</sup> June to 22<sup>nd</sup> June 2024** (this includes arrival and departure)
- 2.4. The Training Placement shall start on **03<sup>rd</sup> Juny 2024**. The total number of days spent in Thesalloniki will be 21.

**3 ARTICLE 3 - FINANCING THE TRAINING PLACEMENT**

- 3.1. For the placement governed by this Agreement, the sending institution undertakes to finance mobility expenditure in accordance with the financing rules established by the Erasmus+ National Agency.

#### 4 ARTICLE 4 - PAYMENT ARRANGEMENTS AND SERVICES

4.1 The sending institution undertakes to pay to the host organisation **total amount of 14806 Euros** to arrange the following services regarding the training placement for 8 interns (**8 interns á 1632 Euros, i.e. 13056 Euros**) + **1 teacher (that is 1750 Euros)**. The first instalment 80% of the total amount of 11845 Euros, deadline 02/05/2024 of the total amount, 20% - 2961,- Euros 18th June 2024.

4.2. Arrangements on the Greek side are: pre-departure/preparatory visit program, June traineeship - accommodation, work placements of our trainees, arrangement of the Work Program according to the Learning agreement, half board, cultural program, excursion at the hospital, Covid tests, transfers from and to the airport, transport to the home for the elderly, mentoring, monitoring at the traineeship site. **Work Placements and accommodation for each intern should be known three weeks prior scheduled arrival at the latest.**

The sending institution undertakes to pay as follows:
