I.

1. The Contracting Parties concluded on 25th January 2021 the above-mentioned Contract for the provision of testing material, as amended by Amendment No. 1 concluded on 6th February 2023 (hereinafter referred to as the "Contract") enabling MB to perform tests of machine control of production/security print quality on 80,000 sheets of tobacco labels (hereinafter referred to as the "Material") handed over by STC. MB was entitled to carry out testing for 12 months following the handover of the Material, i.e. till 12th February 2022.
2. In accordance with provision of the Article III par. 7 of the Contract the testing period was prolonged by another 12 months. Further extension of the testing period until 12th February 2024 was made by Amendment No. 1 to the Contract.
3. Following the request of MB for another prolonging of the Material testing the Contracting Parties have agreed upon a prolongation of the testing period of the Material for another 24 months **till 12th February 2026.**
4. The term of performance of the Contract and any other deadline according to the Contract are hereby extended accordingly.

II.

1. In accordance with the provision of Article VII paragraph 2 of the Contract the Contracting Parties have also agreed upon the following changes to the Contract:
 - a. In header of the Contract, the business name of the STC shall be replaced as follows: "**Státní tiskárna cenin, s. p.**"
 - b. In header of the Contract, the registered office of the STC shall be replaced as follows: "Růžová 943/6, Nové Město, 110 00 Praha 1, Czech Republic"
 - c. In header of the Contract, the identification of the MB shall be replaced as follows:

2. Other provisions of the Contract shall remain unchanged by this Amendment and remain in full force and effect.
