A STATUTORY DECLARATION

on the Absence of Any Conflict of Interest and on International Sanctions

By confirming this order, the supplier specified in the heading of the order (hereinafter as the "Supplier") also declares that it does not have a conflict of interest pursuant to Section 4b of Act No. 159/2006 Coll., on Conflict of Interest, as amended (hereinafter referred to as the "Conflict of Interest Act"), i.e. that:

- 2. The prohibition to purchase, import or transfer specified goods originating in or exported from Russia or Belarus, i.e. the Supplier declares that:
 - it does not trade in sanctioned goods originating in or exported from Russia or Belarus and does not offer such goods for public procurement.
