On 14 July 2023, the Parties entered into the Agreement on Cooperation on the Project „**Focus on Androgen Receptor: Development of Binding Molecules for Prostate Cancer Treatment and Improvement of NMR-AI Platform for More Effective Drug Design**“, on the basis of which the cooperation in solving the tasks of the project No. TM05000031 is taking place. For the settlement of the transfer of funds between the main beneficiary and additional participants according to the rules

set by the Technology Agency of the Czech Republic (hereinafter referred to as "TA ČR"), they enter into the following agreement on the transfer of funds.

## **II. Provision of special-purpose support**

- 2.1** To cover the costs of the solution of the part of the project according to the approved proposal, the funds for the year 2024-2025 (hereinafter referred to as "Funds") will be allocated to the above-mentioned additional participants on the basis of the Contract on the provision of support concluded between TA ČR and the main beneficiary, in the distribution as specified in Annex 3 (Binding parameters of the project solution) to this Contract. The Project Funds will be provided by the main beneficiary to the additional participant within 20 days of receipt of this part of the support from the provider (TA ČR), by transfer to the account of the additional participant as specified in the header of this Agreement. The amount in CZK will be converted to the equivalent amount in CHF (Swiss Francs) for NexMR according to the currency conversion service Exchange.cz. The converted amount will be sent via Exchange.cz to NexMR's bank account in CHF, which is specified in the header of this Agreement.
- 2.2** As part of the submission of the interim report, the additional participant shall submit to the main beneficiary a detailed and transparent account of the management of the allocated funds within the agreed timeframe.
- 2.3** The additional participant undertakes to proceed with the project in accordance with the Contract for the provision of support, the General Conditions of the TA ČR and the Binding Parameters of the project, which form an integral annex to this contract. The additional participant undertakes to draw down the funds in accordance with the applicable General Terms and Conditions, which form an integral annex to this contract.
- 2.4** The contract is drawn up in electronic form, with the beneficiary and both additional participants receiving identical electronically signed copies.
- 2.5** The Parties acknowledge that this Contract is subject to mandatory publication pursuant to Act No. 340/2015 Coll., on Special Conditions for the Effectiveness of Certain Contracts, Publication of Such Contracts and on the Register of Contracts (Act on the Register of Contracts). The Parties agree that the main beneficiary is the party that will ensure the publication of the contract in the Register of Contracts.
- 2.6** This Agreement becomes valid on the date of signature by the authorised representatives of all the Parties and comes into effect from the date of signature.

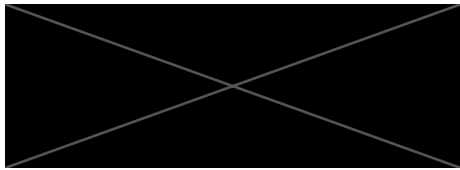

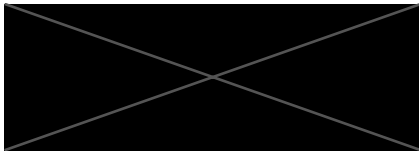

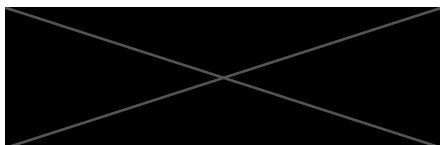
