





The BDS/CSRC key figures for this Project are:

The **Program and Manufacturing Manager** is the focal point for all program issues and will have full authority and responsibility within BDS/CSRC organization to execute all the requirements of this program. He is responsible either versus VZLU and versus the BDS Management for all management, administrative and technical functions, ensuring the performance of the team. The PMM will guarantee that the personnel and facilities necessary for the performance of the program will be assigned and made available at the times and places necessary. He will directly respond to the Top Management of BDS, and will have direct access to the BDS Space Division Managing Director for all the Program needs.

The **Contract Officer** will be responsible for all legal, contractual and administrative aspects of the Program.
