

**AMENDMENT NO. 1**

This Amendment No.1 ("**1<sup>st</sup> Amendment**") is made and entered into by and between Turner Broadcasting System Europe Limited ("**Turner**") and Ceska Televize ("**Licensee**") and amends the Agreement entered into by and between Turner and Licensee dated 07<sup>th</sup> September 2020 ("**Agreement**"). All capitalised terms not expressly defined in this Amendment shall have the same meanings as used in the Agreement.

This letter serves to confirm our mutual agreement:

1. to extend the Term of the Agreement for an additional period from [REDACTED] ("**Effective Date**") to [REDACTED] ("**Extended Term**").

This Amendment shall be automatically extended for further periods of [REDACTED] unless either party gives at least [REDACTED] notice to the other before the expiration of the Extended Term. The Extended Term and each additional period of [REDACTED] shall be the "**Term**".

2. from the Effective Date, Attachment A of the Agreement shall be deleted and substituted with Attachment A attached to this 1<sup>st</sup> Amendment.
3. the License Fees payable during the Extended Term pursuant to Paragraph 1 above as follows and subject to all Terms and Conditions as detailed in the Agreement:

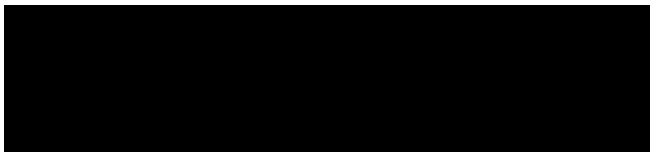

4. In witness whereof, the parties have caused this 1<sup>st</sup> Amendment to be duly executed by their respective authorised officers as of the Effective Date.

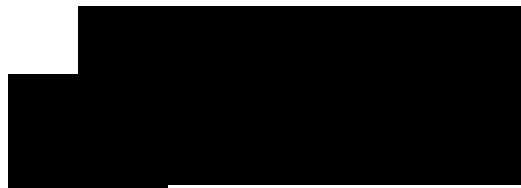

## ATTACHMENT "A" RESTRICTIONS

1. The rights to use Excerpts granted to Licensee under this Agreement extend only to Licensor's programmes set out in Exhibit 1 to this Agreement (*Programmes*) and [REDACTED].  
[REDACTED] Notwithstanding the previous sentence, the rights to the CNN Content granted to Licensee under this Agreement do not extend to the following:
  - (a) Programming materials produced, owned and/or distributed by [REDACTED] unless Authorised Operators has acquired the required rights directly from the third party concerned;

2. Before exercising the rights to the Services granted in this Agreement, Licensee shall remove from the Services all music for which Licensor has clearly indicated on the DDS that the performance licences are held by ASCAP, BMI or SESAC and that the music shall therefore be removed.
3. Licensee shall not broadcast or otherwise distribute by means other than terrestrial broadcast television any materials contained in the Services that are produced and/or owned by the TV Asahi Corporation and/or its subsidiaries, unless Licensee obtains the prior written permission of Licensor in each instance.
4. The programming materials excluded from Licensor's grant of rights as described in paragraphs 1 through 3 above shall be collectively referred to as the *Excluded Materials*. Notwithstanding the restrictions described in paragraphs 1 through 3 above, Authorised Operators are granted the right to use any Excluded Materials which may, from time to time during the Term, be made available via Licensor's digital delivery system (*DDS*).
5. From time to time during the Term, certain usage restrictions relating to third party materials included in the Services may be specified on Licensor's DDS. Licensee acknowledges and agrees that it shall be responsible for monitoring the DDS to determine any such restrictions and agrees to comply with any and all such restrictions.
