

CONTRACTUAL AGREEMENT RE: RG002-N-23

This document contains the terms of agreement between the Chiang Ching-kuo Foundation for International Scholarly Exchange (the Foundation) and *Masaryk University* (the Grantee) concerning Research Grants *RG002-N-23*.

The Foundation agrees to award a grant of *US\$10,000* to the Grantee for the proposed Project entitled: *Tibetans in Taiwan: Food and Identity in a Historical and Contemporaneous Context* (the Project) Grant Funds will be made available on a quarterly basis over a period of *2 years* beginning *January 2024* (the Grant Period).

It is understood that Grant Funds will be used in accordance with the approved Project's original grant application. It is also understood that no modifications may be made to the Project without the Foundation's prior written consent, and that, in principle, modifications may only be done once during the duration of the Grant Period. It is further understood that payment of Grant Funds cannot be made to individuals, but only to institutions.

Any portion of the Grant Funds not expended or committed for the purposes of the Project by the end of the Grant Period shall be returned to the Foundation. By mutual agreement between both parties, the Grant Period can be extended for a reasonable period of time, but only one extension will be allowed, and no further funds will be provided.

One copy of the final report of the Project signed by an appropriate officer of the Grantee's organization shall be furnished to the Foundation within two months after the end of the Grant Period. If the Grant Period exceeds one year, interim reports shall be furnished annually during the Grant Period, in addition to the final report. In the case of a multi-year grant, payments beyond the first year will not be made until the interim report(s) for the preceding years(s) have been received by the Foundation before August 15. These reports should contain: (1) a narrative account of what was accomplished by the expenditure of funds granted, including a description of progress made toward achieving the goals of the grant; and (2) a financial report according to the line-item categories of the budget plan. It is expected that the narrative and financial report will be submitted as a single document.

The Foundation reserves the right to post Project abstracts and reports on its websites. The Foundation may also include information pertaining to this grant in its periodic public reports, and refer to the grant in its press releases. If the Grantee wishes to make separate press announcements, it is advisable to consult the Foundation in advance.

Any publications resulting from the Project should acknowledge the Foundation's support. In addition, two (2) copies of such publication(s) should be provided to the Foundation. Recipients of a Publication Subsidy Grant must send five (5) copies of their published material to the Foundation. All book-length publications sent to the Foundation should be accompanied by a one-page abstract. The provision of publications does not absolve the Grantee of the responsibility of submitting timely narrative accounts and financial reports as stipulated above.

The Grantee agrees to give non-exclusive free license of all Project research results and works to the Foundation for non-commercial and not for profit purposes. In order to keep pace with advantages in digital technology, as well as ensure the widest possible circulation of research results, the Foundation reserves the right to store, disseminate, and otherwise distribute Project research results and works in DVD or any digitized or other format, including those formats that are not yet in existence. The Foundation may also effect changes in format to facilitate needs for storing and internet services.

The Grantee guarantees that all aforementioned research results and works of the Project will represent works of original scholarship and will not infringe upon any other person's intellectual property rights. The Foundation will not be held responsible for any violations of such rights.

The Foundation may periodically monitor and conduct reviews of Project operations, which may include visits by Foundation personnel to the Project site to observe and discuss relevant matters with the grantee's staff. The Foundation's staff may wish to review financial and other records and materials connected with the activities financed by the grant.

The Foundation maintains the right to terminate this agreement, whereupon the Grantee shall return all Grant Funds not expended, upon the occurrence of one of the following events: (1) the Foundation in good faith believes that the goals of the Project cannot be reached, or research work cannot proceed in accordance with the approved grant application; (2) the Grantee fails to observe any provisions set forth in this contract.

If this document correctly sets forth the terms and conditions of our agreement, please indicate your consent thereto by having the enclosed copy of this contract countersigned by a duly authorized officer of your organization and returned to the Foundation.
