The higher education institutions must respect the following set of quality principles and general requirements under the SEMP Charter and agree to:

- Respect in full the principles of non-discrimination and to promote and ensure equal access and opportunities to mobile participants from all backgrounds, in particular disadvantaged or vulnerable groups.
- Apply a selection process that is fair, transparent and documented, ensuring equal opportunities to participants eligible for mobility.
- Ensure recognition for satisfactorily completed activities of study mobility and, where possible, traineeships of its mobile students.
- Charge no fees, in the case of credit mobility, to incoming students for tuition, registration, examinations or access to laboratory and library facilities. Nevertheless, they may be charged small fees on the same basis as local students for costs such as insurance, student unions and the use of miscellaneous material.

The higher education institutions further undertake to:

Before mobility

- Provide information on courses and placement options (content, level, scope, language) well in advance of the mobility periods, so as to be transparent to all parties and allow mobile participants to make well-informed choices about the courses / placements they will follow.
- Ensure that outgoing participants are well prepared for the mobility, including having attained the necessary level of linguistic proficiency.
- Ensure that student mobility for studies or training purposes is based on a learning agreement / study plan, if possible validated in advance between the sending and receiving institutions or enterprises and the mo-
- Provide assistance related to obtaining visas, when required, for incoming and outgoing participants.
- Provide assistance related to obtaining insurance, when required, for incoming and outgoing participants. The institutions should inform mobile participants of cases in which insurance cover is not automatically
- Provide guidance to incoming mobile participants in finding accommodation.

During and after mobility


- Ensure equal academic treatment and services for home students and incoming mobile students and integrate incomings into the institution's everyday life, and have in place appropriate mentoring and support arrangements for mobile participants.
- Accept, if possible, all activities indicated in the learning agreement / study plan as counting towards the degree, provided these have been satisfactorily completed by the mobile student.
- Provide, free-of-charge, incoming mobile students and their sending institutions with transcripts in English or in the language of the sending institution containing a full, accurate and timely record of their achievements at the end of or shortly after their mobility period.
