Amendment No. 1 **Contract for Work and Service support**

“System for design and management of instrument flight procedures and airspaces”

Concluded pursuant to Section 2586 et seq., 2358 et seq. and 1746 paragraph 2 of the Civil Code 89/2012 Coll., as amended, (hereinafter referred to as “**Civil Code**”)

(hereinafter referred to as the “**Amendment**”)

Hereinafter individually or collectively referred to as a “**Party**” or the “**Parties**”.

2. Preamble of the amendment

2.1 WHEREAS, on May 19, 2023 both Parties signed the Contract for Work and Service Support (Contract No. ANS CR: 267/2022/IS/120) (hereinafter referred to as the "**Contract**") the subject of which is to provide the Client with System for design and management of instrument flight procedures and airspaces and with service support for such system,

2.2 WHEREAS, the monthly payments for Service support proved burdensome for both Parties,

2.3 WHEREAS, the payment for Service support for the term starting with the entry into force of the Contract and ending with 30th June 2023 was yet paid on the basis of Contract No. 066/2021/PS/036 concluded between the Parties on 7th June 2021,

the Parties have agreed, in accordance with Article 222 paragraph 3 and paragraph 6 of Act No. 134/2016 Coll., on public procurement, to amend the Contract as follows.

3. The subject of the Amendment

3.1 Article 4.2.4 of the Contract shall be modified and shall be newly read as follows:

„4.2.4 Payment of Service support according to Article 3.1.4 of this Contract shall be invoiced quarterly on the basis of an invoice issued by the Contractor by the last day of the calendar quarter when the Service support was provided.“

3.2 Article 6.2 of the Contract "Terms of performance" shall be modified and shall be newly read as follows:

The Service support shall be provided from the 1st July 2023 till 23rd May 2033.

4. Final Provisions of the Amendment

4.1 All the other parts of the Contract shall not be changed by this Amendment.

4.2 *Publication:* The Contractor acknowledges that the Client is obliged to publish this Amendment pursuant to the Act No. 340/2015 Coll., on the Register of Contracts, as amended, in particular the following information contained in this Amendment shall not be published: Contractor's bank account details in Article 1 of this Amendment and signatures on the Amendment.

4.3 This Amendment shall become valid on the day of its signature by both Parties and effective on January 1, 2024.
