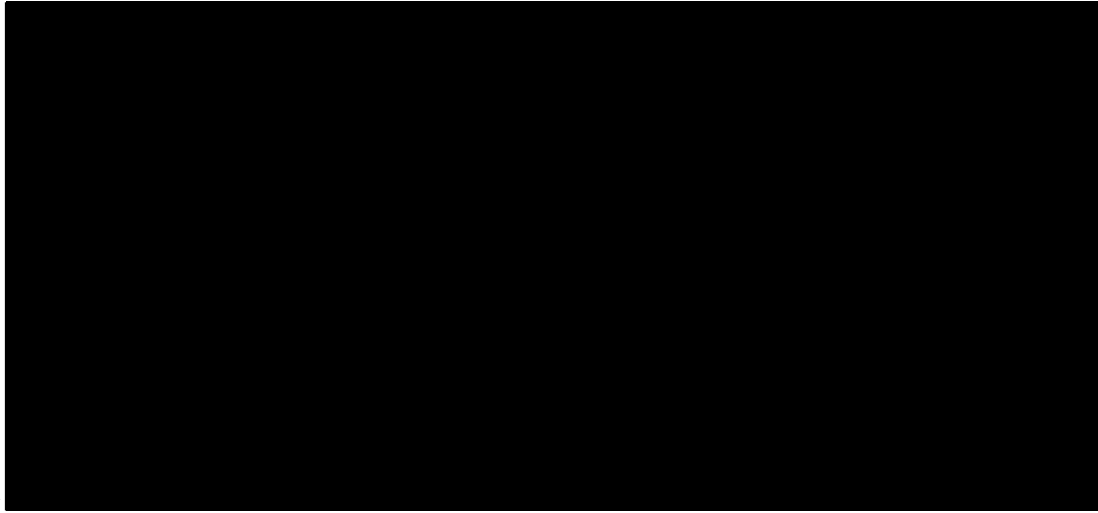

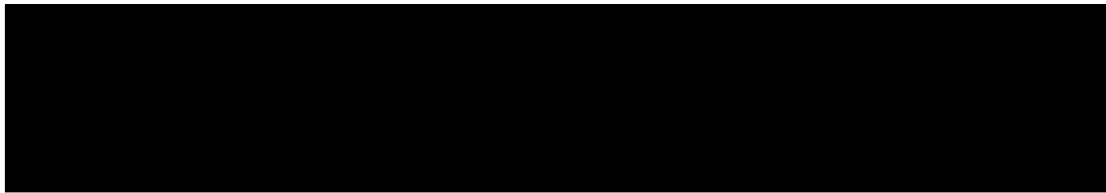

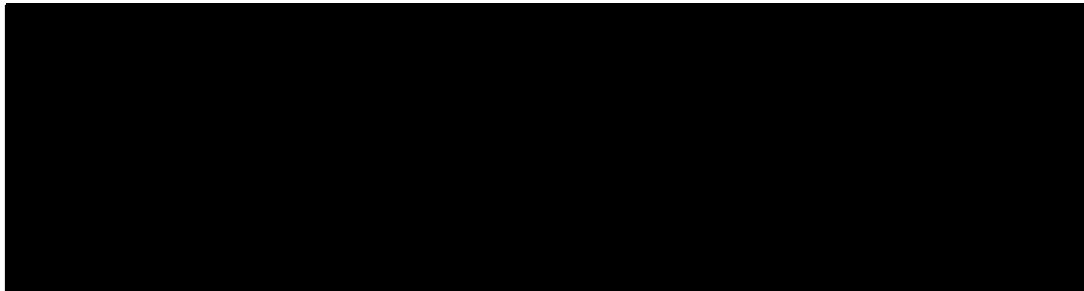


8. Pharmaron UK Ltd will develop "fit for purpose" LC-MS/MS bioanalytical methods to provide quantification of the test materials.

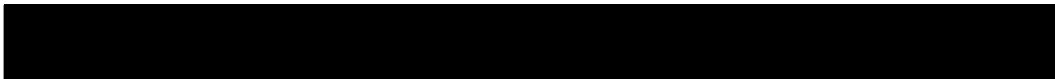
