

PERFORMANCE CONTRACT

Agreement made between the undersigned.

The Promoter:

Mr. **Luděk Strašák** on behalf of the **Městské kulturní středisko (Town Cultural Center) in Namest nad Oslavou**, IC: 18127746, located in Namest nad Oslavou, Masarykovo namesti100 (Czech Republic), VAT number: CZ 18127746

and

The Artit:

Catrin Finch & Aoife Ni Bhriain

Represented by **Dilwyn Davies**, on behalf **Theatr Mwldan**, located in Bath House Road, Cardigan SA43 1JY43, WALES. Company Registered Number: 2701986; VAT number: 485 1852 20;

The Artit declares that he is a payer of value added tax (VAT).

The Artit is domiciled in UK.

Here in afer named rrespectely as «Promototer» and «Art», it is agreed that:

1. The Artit, composed of n. 4 persons on the road including 2 artsts , agrees to appear as known for n. 1 performance held on **July 29, 2024** in **Namest nad Oslavou** (Czech Republic) as a part of Folk Holidays Festi al 2024 and 1 particip aon at the colloquy on July 29, 2024 in Namest nad Oslavou.
2. For the above -mentoned performances, The Promoter grants the Artist an artists´ fee corresponding to the total amount 2500 EUR net of any taxes divided into 1500 EUR for performances, 1000 EUR for particip ation inolloquy.
3. For the booking fee, The Promoter grants the Artist the total amount 500 EUR net of any taxes.
4. The Promoter grants the Artist internationaltravel cost £ 847,27. The Artist will send a bill of international tr vel to the Promoter.
5. The Promoter will arrange and pay, in addition,local transport from Vienna airport to Namest nad Oslavou (arrival on July 28, 2024) and back on day of departure (July 30, 2024).
6. The Promoter will arrange, in addition,catering and accommodaatiofor 4 people in hotel: 2 single rooms and one twin room for 2 nights (July 28 and 29).
7. The Promoter will effect the payment of the sum here above mentioned - point n. 2, 3 - by electronic bank transfer as follows:
 - payment of £847,27 will be paid to the Artist no later than 7 days afer the Promoter will receive a bill of international tavel and the invoice

- payment of 3000 EUR will be paid to the Artist no later than 29 July, 2024

8. The Promoter will arrange and pay sound, lights and backline according to the rider.
9. All shows of the Folk Holidays festival will be recorded by the Promoter – the purpose is only the festival's archive. Every usage for public is under permission of the Artist.
10. Cancellation by Force Majeure: If the performance(s), object of this contract, cannot take place in whole or in part due to any reason considered by International Law as a Force Majeure or any other event beyond the Promoter's and The Artist's control, neither party shall have the obligation to fulfil the original contract and both parties will be exempted from their obligations. Each party shall bear its own expenses and no damages shall be claimed. In the case that money was advanced to The Artist by The Promoter, it should be returned to The Promoter in the shortest delay.
11. The present contract of agreement is valid if sent by email 1 scan copy of it is to be signed for acceptance and returned within February 29, 2024.
12. The file with rider, including the request for backline, the stage plan is an attachment to the contract.

This simple contract will be published in the Register of Contracts under Act No. 340/2015Sb. on the Register of Contracts. The publication will be provided by the Promoter.
