Evaluation Results: Holder received under vacuum. Bottom shutter screw missing. Barrel pushed in and rotated in the flange. Holder will have to be disassembled for repairs. Clamping on sample grid is loose. Crack in dewar housing of cryostation. Holder passed vacuum leak check and connects to temperature controller - reads 22.5°C. Supporting parts will need to be replaced. O rings will be replaced. The holder will be repaired, aligned and then tested to ensure proper functions. The holder will be leak checked, baked and freeze tested.
