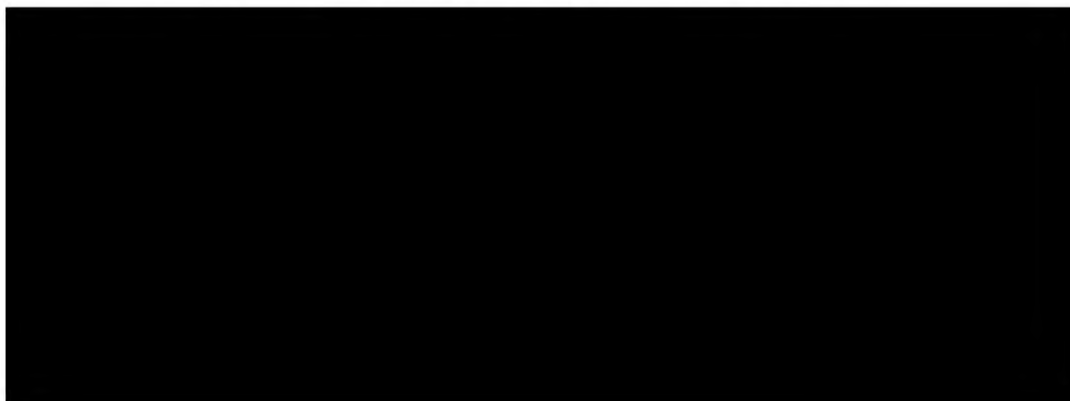
2.2. The purpose of this Agreement is the application or use of results proving the effectiveness of the subsidy provided to support the project from public funds.

3. DEFINITION OF ACHIEVED RESULTS AND THEIR COMPARISON WITH PROJECT GOALS

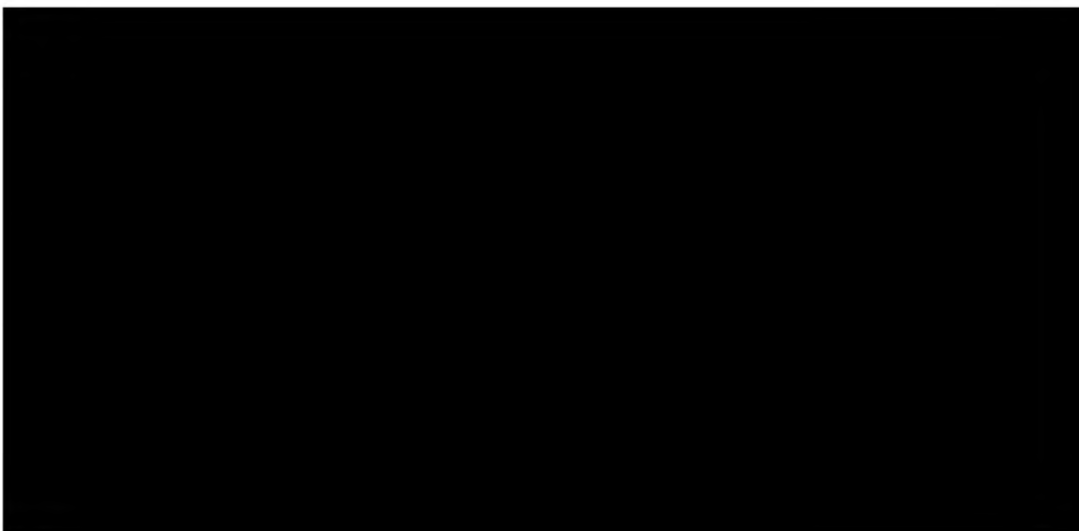
3.1. The following results were achieved by solving the project with the participation of MUNI:

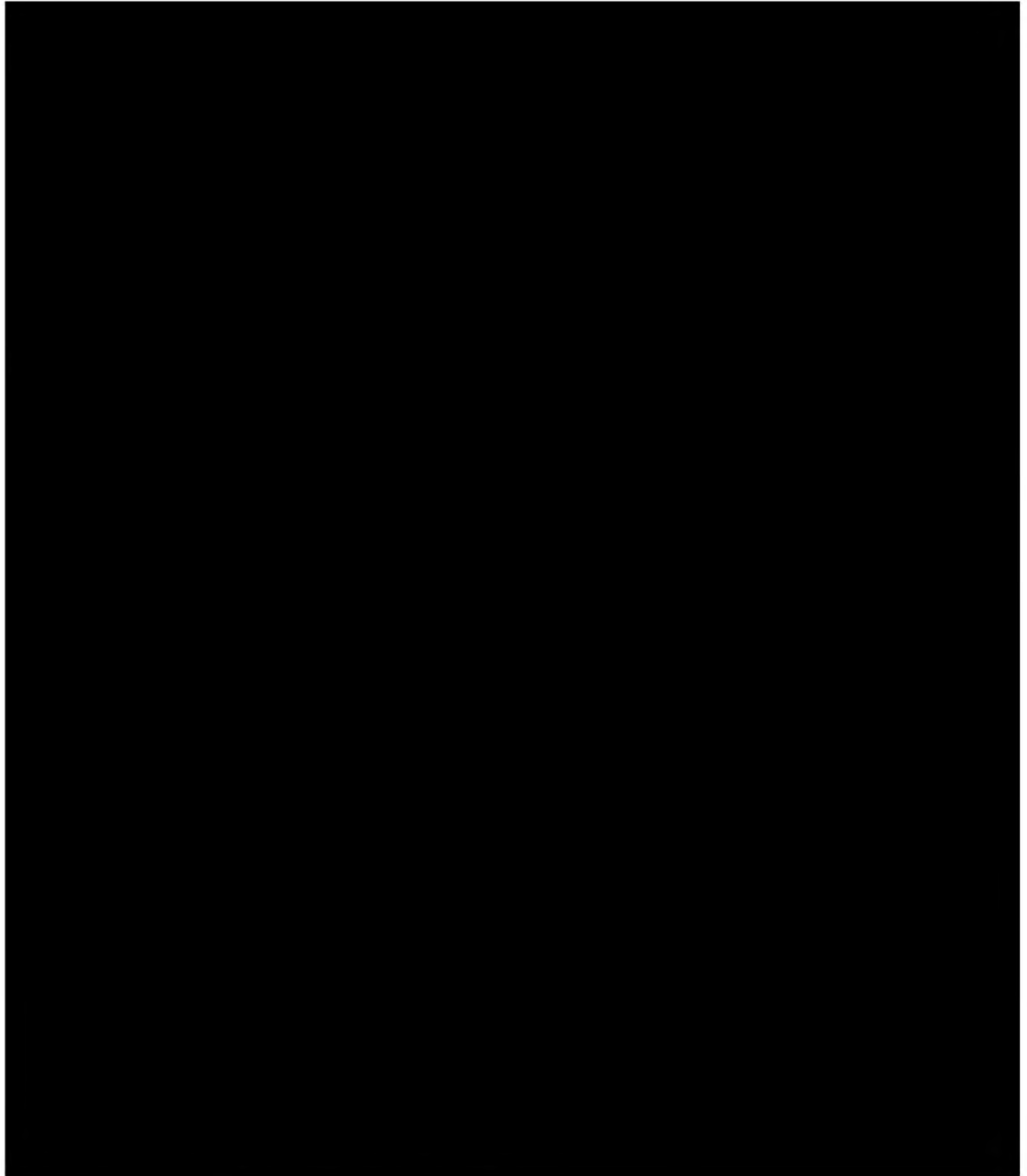

6.1. All the results mentioned in Article 3.1. of this Agreement do not constitute any confidential information that should be handled according to special legal regulations.

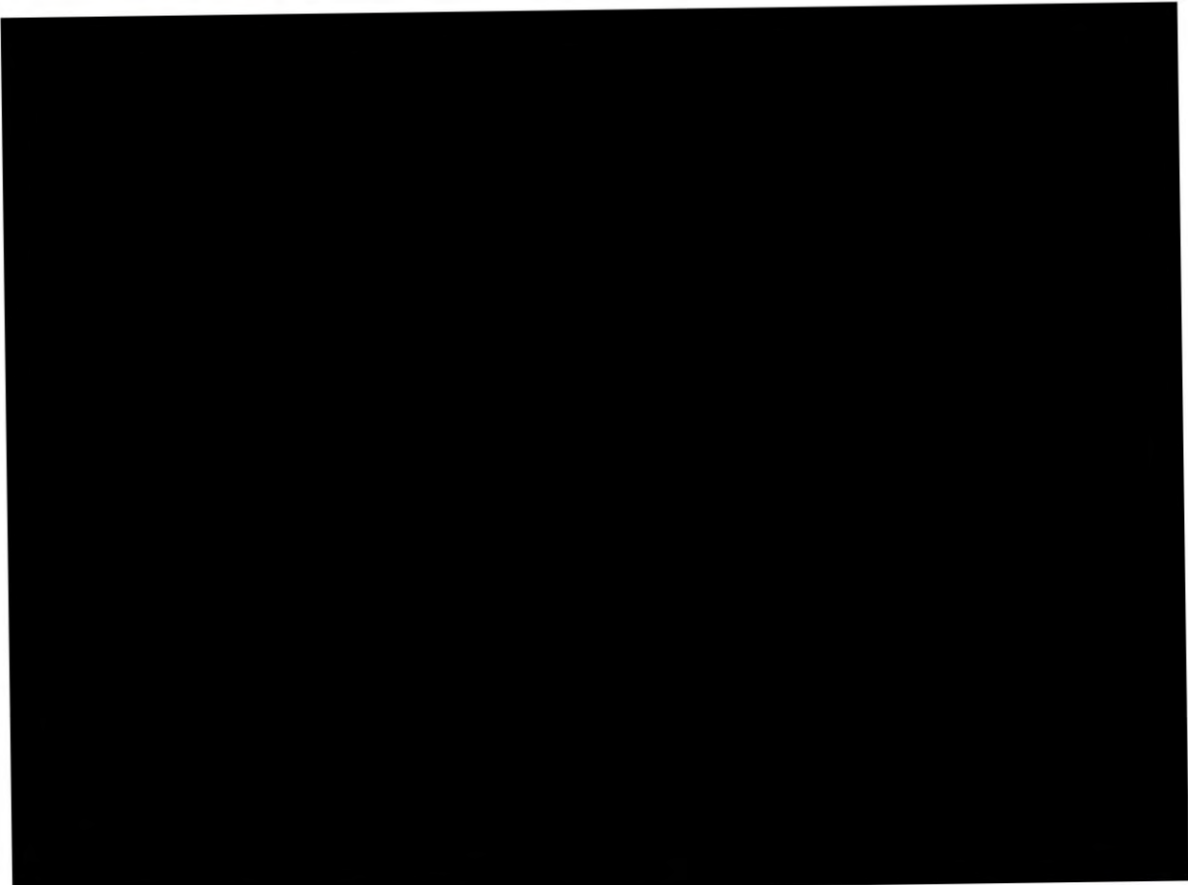
7. DURATION OF CONTRACT OBLIGATIONS

7.1. This contract is concluded for an indefinite period.

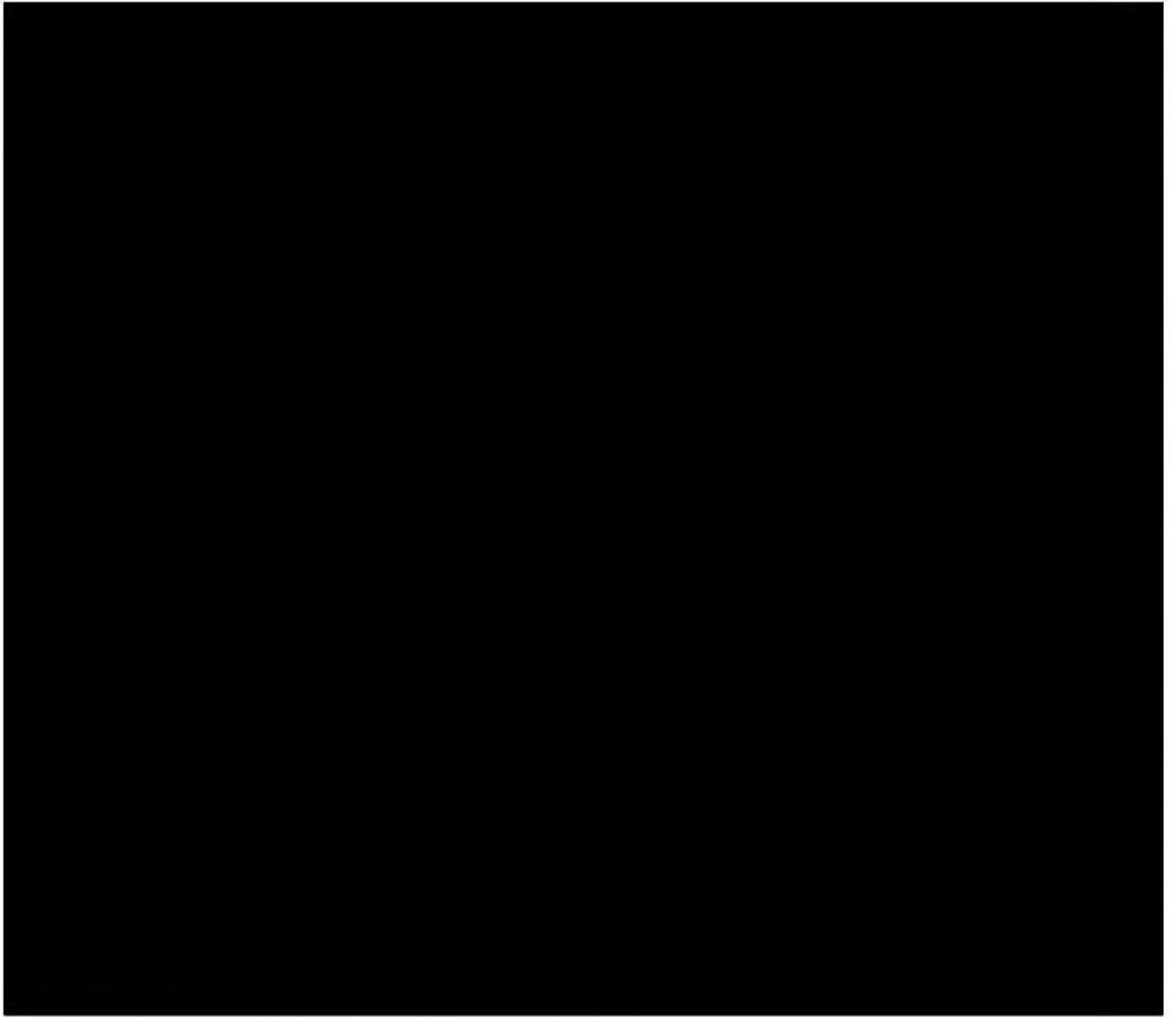
7.2. The termination of obligations arising from this Agreement must be in writing.

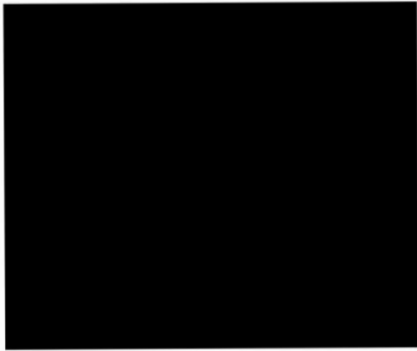


Executed on 28/03/2024, in seven original copies.

In the event of a disagreement as regards the interpretation or performance of the Agreement, the Parties shall endeavour to settle their dispute amicably.

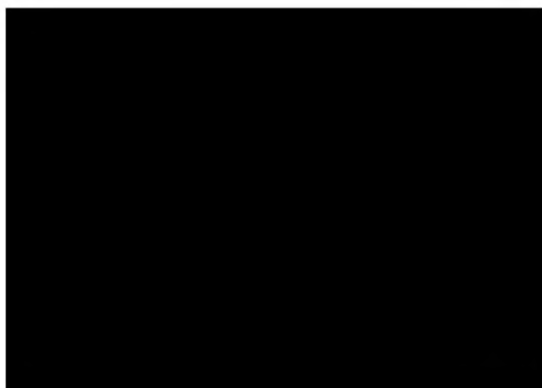

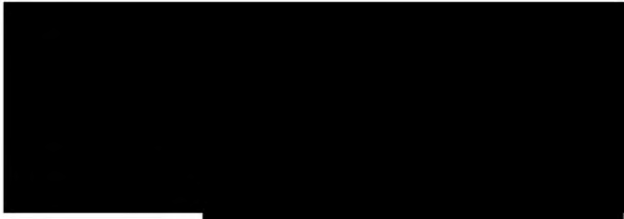
