SPONSORSHIP AGREEMENT

AN AGREEMENT made on the 26th day of March 2024

BETWEEN

the European Federation of Catalysis Societies (EFCATS) with official seat in Rond Point Schuman 14, Brussels (Belgium), (hereinafter called "The Sponsor") of one part

AND

The Faculty of Science, Charles University, Prague (hereinafter called "The Faculty") of the other part

WHEREBY IT IS AGREED

1. In consideration of the agreement by the Sponsor to pay the Society the sum of €. 2,000.00 (Two thousand Euro) to sponsor the 2024 SCHOOL on catalysis.

The 2024 School on Catalysis organized by the **Faculty of Science**, **Charles University**, **Prague** will be held from 28-30 May 2024 in Liblice Castle (Czech Republic).

2. CREDITS AND BENEFITS TO SPONSOR

The Faculty agrees:

to credit the Sponsor by giving the Sponsor's name (and details of value of the Sponsorship) in all Society press releases concerning the 2024 SCHOOL on catalysis;

- a) to pay all costs of 1 invited speaker;
- b) to give the Sponsor prominent acknowledgement in the program booklet related to 2024 SCHOOL on catalysis;
- c) to give the Sponsor prominent acknowledgement on the website, http://www.school.katalyza.cz/, and social media for 2024 SCHOOL on catalysis;
- d) to present logo of the Sponsor on the introductory part of each set of conference lectures;
- e) to provide the Sponsor full page for a business advertisement in the program booklet and book of abstracts;
- f) to offer to the Sponsor a 5-minute address during the conference gala dinner.

PAYMENT

3. Payment of the said sum of \in 2,000.00 (Two thousand Euro) shall be made in full not later than the 10th day of May 2024.

OTHER AGREEMENTS

4. It is agreed that all matters relating to the administration of the sponsorship shall be and remain the exclusive responsibility of the Society.

- 5. It is agreed that in the event of 2024 SCHOOL on catalysis being publicised or covered by any medium such as radio or television, the Society's best endeavours will be directed towards ensuring that the Sponsor is credited.
- 6. It is agreed that the Sponsor will receive an invoice for the agreed sum not later than the 20th day of April 2024.
- 7. In the event of the cancellation of the event 2024 SCHOOL on catalysis, for whatever reason, this Agreement shall be null and void. The Society shall forthwith return to the Sponsor the remaining unspent balance of the sum referred to in clause 3 and paid to the Society, together with full accounting of the monies spent from the said sum up to the date of reimbursement.
- 8. No business relationship is established or implied with this sponsorship agreement. The Sponsor has no liability or responsibility to the Society beyond the scope of this agreement.
- 9. This agreement will be governed and executed in accordance with the Laws of Belgium.
