

Addendum to the Aurora 2030 Consortium Agreement

In connection with the Aurora 2030 project this addendum extends the existing Consortium Agreement (effective date 1. March 2024) which the following organizations have entered into:

WHEREAS, to be aligned with national and internal policies, the parties wish to ratify and affirm the terms of the Consortium Agreement, regarding Article 8.2. PAYMENTS, and each party's assumption of obligations thereunder. NOW, THEREFORE, this Addendum modifies and adds to the Consortium Agreement as follows:

The two final paragraphs of Article 8.2.2 of the Consortium Agreement shall be replaced by the following language: Considering that the Central Office is not in a position to financially contribute

20% of its allocated budget, Parties will contribute in equal shares to the “own contribution” of the Central Office, which is € 419,953 being 20% of the budget allocated to the Central Office which totals to € 2,099,766. The Central Office will also take its share as a result of which the per capita contribution is $419,953 / 10 = € 41,995$.

The clearing of these contributions will be done with the disbursement of EACEA funds, or by invoicing partners in the event individual partners prefer that.

The per capita contribution of € 41,995 is the maximum contribution that will be required from partners for covering the own costs of the Central Office.

In the event the total costs of the Central Office over the full duration of the project will be less than € 2,099,766, the proportional per capita contribution will be reimbursed to partners with the last disbursement of EACEA funds, or upon receiving the partner’s invoice if so preferred.

Except as set forth in this Addendum, all other provisions of the Consortium Agreement, shall continue to remain in full force and effect for the term of the Consortium Agreement.
