#### Dear Sir or Madam:

Reference is hereby made to that certain Television License Agreement by and between UNIVERSAL STUDIOS LIMITED ("Licensor") and CESKA TELEVIZE/CZECH TELEVISIO ("Licensee") dated June 22, 2023 (the "Agreement"). This letter agreement (this "Amendment") memorializes the agreement between Licensor and Licensee with respect to amending the Agreement. The terms of the Agreement are hereby incorporated herein by reference and, unless otherwise defined herein, capitalized terms used herein shall have the meanings set forth in the Agreement. To the extent that the terms of the Agreement are inconsistent with the terms of this Amendment, the terms of this Amendment shall govern.

WHEREAS, Licensor and Licensee have agreed that
shall be withdrawn and replaced with a 120' episode version respectively.

NOW THEREFORE, in consideration of the promises contained herein and for other good and valuable consideration, the receipt, adequacy, and sufficiency of which the parties hereby acknowledge, Licensor and Licensee hereby agree to amend the Agreement as follows:

1. The No. of Episodes as specified in the Schedule of the Agreement shall be amended as follows:

- 2. The Exhibit A attached to the Agreement shall be deleted in its entirety and replaced with the Exhibit A attached hereto.
- 3. Miscellaneous.
  - (a) Amendments; Waivers. This Amendment may only be amended or modified in a writing signed by both parties. Any waiver of any right or remedy requires the written consent of the party waiving it. No failure by any party to insist on the strict performance of any provision of this Amendment, or to exercise any right or remedy, shall be deemed a waiver of such performance, right or remedy, or of any other provision of this Amendment.
  - (b) <u>Integrated Agreement</u>. Except as amended by this Amendment with respect to the subject matter hereof, the Agreement shall continue in full force and effect. The Agreement, as amended by this Amendment, constitutes the complete and exclusive statement of the agreement between the parties hereto, and supersedes all prior proposals and understandings, oral and written, relating to the subject matter contained therein.
  - (c) <u>Sections and Other Headings</u>. Sections or other headings contained in this Amendment are for reference purposes only and shall not affect in any way the meaning or interpretation of this Amendment.

- (d) <u>Signatures</u>; <u>Counterparts</u>. This Amendment may be executed in counterparts, each of which will be deemed an original and all of which together constitute one and the same instrument. Documents executed by authorized signatories utilizing electronic signatures shall be as legally binding for all purposes as documents executed with original handwritten signatures, and no certification authority or other third-party verification is necessary to validate their electronic signature. In addition, copies of duly executed documents (e.g., PDF copies received via email, facsimile copies, etc.) shall be as legally binding for all purposes as the originals. The parties hereto acknowledge and agree that in any legal proceedings between them respecting or in any way relating to this Amendment, each waives the right to raise any defense based on its execution by electronic means or the unavailability of the original executed document.
- (e) <u>Severability</u>. If any provision or part-provision of this Amendment is or becomes invalid, illegal, or unenforceable, it shall be deemed modified to the minimum extent necessary to make it valid, legal, and enforceable. If such modification is not possible, the relevant provision or part-provision shall be deemed deleted. Any modification to or deletion of a provision or art-provision under this clause shall not affect the validity and enforceability of the rest of this Amendment.
- (f) Governing Law; Jurisdiction; and Venue. The governing law, jurisdiction, and venue sub-paragraph of the Miscellaneous paragraph of the Agreement hereby is incorporated in this Amendment and applies with equal force and effect to this Amendment as to the Agreement.
