WHEREAS:

- (1) On 1st of March 2015 the NEMOs and DBAG have entered into a license agreement under which DBAG has granted a license for amongst others the XBID Solution (the "**License Agreement**");
- (2) The XBID Solution's Source Code (including new releases which are to be deposited under <u>Section 10.1</u> of the XBID-DSA License and necessary information on third party libraries used by the XBID Solution) of the XBID Solution has been deposited with Deposix pursuant to the escrow agreement entered into by the NEMOs, DBAG and Deposix on 1st of March 2015 (the "**Escrow Agreement**");
- (3) New NEMO has acceded to the License Agreement and now wish to become a party to the Escrow Agreement under the same rights and conditions as those granted to NEMOs.

NOW THEREFORE THE PARTIES AGREE AS FOLLOWS:

Section 1. Accession to the Escrow Agreement

1.1 New NEMO declares to be fully aware of, to acknowledge and to accept the terms and conditions of the Escrow Agreement.

As of the date of entry into force of this Accession Agreement, the NEMOs, DBAG and Deposix hereby accept the accession by New NEMO to the Escrow Agreement and accept New NEMOs as a party to the Escrow Agreement under the same conditions as those granted to the NEMOs under the Escrow Agreement.

Section 2. Remuneration of the Services

Following the receipt of the relevant invoice of Deposix, the New NEMO shall pay in accordance with the terms of Section 8 and Appendix G of the Escrow Agreement its individual share of the remuneration to be paid to Deposix for the Services provided by Deposix as of the date mentioned under Section 3 of the Accession Agreement. It is understood that the Services provided to the New NEMO shall be invoiced as of the date agreed with the NEMOs.

Section 3. Entry into force and termination


The Accession Agreement shall enter into force, with retroactive effect, on 1st May 2024, provided it has been signed by all Parties. The Accession Agreement is entered into for the duration of the Escrow Agreement. For the avoidance of any doubt, should the Escrow Agreement be earlier terminated, the Accession Agreement shall be terminated accordingly.

Section 4. Miscellaneous

- 4.1 If one or more of the provisions of this Accession Agreement are declared to be invalid, illegal or unenforceable in any respect under any applicable rule of law or public policy, the validity, legality and enforceability of the remaining provisions contained herein shall not in any way be affected and these provisions shall remain in full force and effect as long as the economic or legal substance of this Accession Agreement is not affected in any material manner adverse to any Party. In such event, the Parties shall immediately and in good faith negotiate a legally valid replacement provision with the same economic effect.
- 4.2 Parties may not assign or transfer this Accession Agreement, partially or as a whole.
- 4.3 This Accession Agreement is governed by and construed in accordance with the laws of Germany.
- 4.4 Any dispute arising out of or in connection with this Accession Agreement shall be settled in accordance with the Escrow Agreement.
- 4.5 OTE has a national legal obligation within the meaning of Section 2 (1) of the Czech Act No. 340/2015 Coll., on special conditions for the effectiveness of certain contracts, publication of these contracts and register of contracts (Act on the Register of Contracts), as amended and therefore the Accession Agreement shall be published by OTE in the Czech Register of Contracts pursuant to section 5 of the Act on the Register of Contracts.

No Confidential Information shall be disclosed during the course of complying with such obligation, including by redacting all such confidential information from any materials or documents, unless specified otherwise in the Act on the Register of Contracts.

The Parties shall receive from OTE a redacted version intended for the fulfilment of the abovementioned obligation. The Parties shall notify OTE without undue delay in case they identify the necessity for further redaction to the received redacted version, otherwise it is deemed that the Parties approved the publication of the received redacted version.




