### **Amendment to the Loan Agreement**

(hereinafter referred to as the "**Amendment**")

#### **I. Introductory Provisions**

1. On 11/11/2019, the contracting parties concluded the Loan Agreement No. DO 18\_19/00069922/2019 (hereinafter referred to as the "**agreement**").

2. As part of the agreement, the contracting parties have agreed on free borrowing of copyrighted works, specified in the annex to the agreement (hereinafter referred to as “**works**”), for the period from 1 November 2019 to 15 August 2024.

## **II. Subject of amendment**

1. The subject of this amendment is:

- a) modification of the subject of the agreement

From the signing of this amendment, the subject of the agreement is not primarily the loan, but the safe **storage of the relevant works** (this change does not exclude the possibility of exhibiting the works).

- b) negotiation of remuneration for borrowers

Lenders undertake to pay the borrower a **fee of CZK 100.000** (in words: one hundred thousand Czech crowns) **for the storage of the relevant works**.

The remuneration will be paid on the basis of an invoice for Dr. Marketa Evans, within 30 days from the date of signing of this Amendment, otherwise the agreement is cancelled, unless the contracting parties agree otherwise.

- c) duration change

The works will be stored by the borrower **until 31 May 2029**.

## **III. Final provisions**

1. This amendment becomes valid and effective on the day it is published in the Register of Contracts.
2. Other provisions of the agreement, unless the nature of this amendment precludes it, are not affected by this amendment.
3. This amendment was made in four copies, the borrower will receive 2 copies (English and Czech version) and each lender will receive 1 copy (English version).
