HAVE AGREED AS FOLLOWS

### **Art. 1 - Purpose and duration**

The host and the partner have agreed to co-organise the NET activity Europe Talks Solidarity Activities (conference and webinars) 2024\_NIVAM\_NAE+\_40

- 1.1. The period of eligibility of costs shall begin at the earliest from 01.01.2024 and end at the latest of 31.12.2024 inclusive.

### **Art. 2 – Financing**

- 2.1. The partner agrees to make a financial contribution to the direct costs related to the above-mentioned activity in particular to the following costs:
  - a. Facilitation and speaker costs of Europe Talks Solidarity Conference 2024
  - b. Facilitation, speaker costs and video editing of Europe Talks Solidarity webinars 2024
- 2.2. The host and the partner agree that the maximum amount of the financial contribution of the partner is 5.000 €.
- 2.3. It is the responsibility of each of the partners to ensure and keep proof of the co-funding of the activity from other sources than the EU funding.

### **Art. 3 – Payments**

- 3.1. The partner will pay the amount specified in article 2.2 within 30 days upon a written request for payment or invoice from the host to the partner.

The written request for payment or invoice will be accompanied by:

- a. final overview of the total expenditures and incomes
- b. Report of the activity as specified in article 4

**Art. 4 - Report**

- 4.1. The host will provide a report within two months following the project end date set out in Article 1.1. The report will contain minimum the following information:
  - a. Description of the activities undertaken (events, topics)
  - b. Main outcomes of the activities: Specifically
    - i. Number of participants at the events
    - ii. Results of the evaluation by the participants

**Art. 5 – Other provisions**

- 5.1. The host NA commits itself to undertake the project in full respect of the EU-programme European Solidarity Corps' regulatory framework, in particular with respect to sound financial management, non-profit, procurement rules and NET rules.
- 5.2. The agreement shall enter into force on the date when the last of the two parties sign and take effect on the day following its publication in the Central register of contracts of Slovak Republic. Publication will be provided by the host NA.
- 5.3. Made in English language, in 2 hard copies.
- 5.4. In the event of a dispute arising between the contracting parties, the court of the Slovak Republic will be competent and legal order of Slovak Republic will be applicable.
