

AMENDMENT NO. 1 TO CONSULTING AGREEMENT

(together as “the Contracting Parties”).

I.

1. This Amendment modifies Consulting Agreement, which regulates the terms and conditions of cooperation between IKEM and Member of ISAB within the CarDia project that was signed by the Contracting Parties on 16.10.2023.

2. The Contracting Parties have agreed to amend Article II of the Consulting Agreement in such a way that paragraphs 4 to 6 of wording bellow are added to the current Article II as follows:

(4) *„The consideration will be paid by IKEM in accordance with delivered written statement of hours of each Member of the ISAB connected with provided supervisory and advisory Services in the field of management and project*

administration for IKEM. The company [REDACTED] advokát will issue an invoice and timesheets according to which the consideration will be paid. Each ISAB member is remunerated at a rate of EUR 175 per hour of project-related work.“

- (5) Reimbursement for the work of an ISAB member will be paid on the basis of timesheets and invoices submitted twice a year, on 30 April and 31 October.
- (6) The Consideration is payable within one month.“

II.

1. The introduction of the change doesn't affect remaining terms of Consulting Agreement which remain the same.
2. This Amendment no. 1 is concluded by the signature of all Contracting Parties and is made in two executions. If this Amendment no. 1 is signed with a guaranteed electronic signature, it is made in one execution. This Amendment no. 1 comes into effect by publishing in the Register of Contracts in accordance with the Act No. 340/2015 Coll., on the register of contracts as amended.
3. IKEM and the Member of the ISAB declare that they have properly acquainted themselves with the content of this Amendment no. 1, that this Amendment no. 1 was concluded after mutual discussion as an expression of their true and free will, definitely and comprehensibly and not under duress or under any conspicuously disadvantageous conditions.
