Whereas on February 10th 2022, the Parties entered into the DISTRIBUTION LICENSE AGREEMENT (hereinafter also referred to as the "Agreement") whose purpose is to distribute the Publications provided by Licensor to Authorized-User via CEEOL's repository database and website www.ceeol.com which shall be maintained by the Distributor under the Agreement (hereinafter referred to as the "database").

Whereas the Parties have agreed that the new Journals as Publications issued by the Licensor, specified in this amendment, will replenish the database.

Therefore, in order to duly add the said new Journals, as Prospective Content, to the Agreement in line with the Art. 1. par. 1.8. of the Agreement, the Parties

**enter into this AMENDMENT No. 1 to the DISTRIBUTION LICENSE AGREEMENT
concluded by and between the Parties on February 10th 2022:**

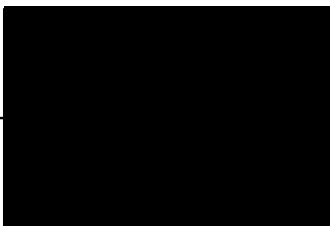
