1. **THIS ADDENDUM** is made on the ..... day of ..... 2024 by and between **Mrs. Gertrude Banda** of Roan Road 51c, Kabulonga, Lusaka, Zambia (hereinafter referred to as "the Landlord") and the **Czech Development Agency** of Nerudova 3, 118 50 Prague 1, Czechia, represented by its Director Mr. Michal Minčev (hereinafter referred to as "the Tenant"). Together, the Landlord and the Tenant are hereinafter referred to as "the Parties".
  - a) **WHEREAS** the Parties have entered into a Tenancy Agreement dated 8<sup>th</sup> of February 2024 (hereinafter referred to as "the Agreement") for the lease of Roan Road 51c, Kabulonga, Lusaka, Republic of Zambia (hereinafter referred to as the "Demised Premises");
  - b) **AND WHEREAS** due to the prevailing electricity shortages in range unpredictable in period of signature of the Agreement connected to a period of severe drought in the Republic of Zambia, it has become necessary for the Landlord to incur additional expenses to secure an adequate supply of electricity and water to the Demised Premises independently on electricity provider;
2. **NOW, THEREFORE**, in consideration of the mutual covenants and agreements herein contained, the Parties hereto agree to modify the original stipulation under Clause 2a) in the Agreement, which reads as follows:

*"The Landlord hereby lets unto the Tenant the Demised Premises TO HOLD unto the Tenant from the 1st day of January, 2024, (Two Thousand and Twenty-four), for a term of 2 (Two) years, PAYING THEREOF, during the said term a monthly rent of USD \$1,300 (One Thousand, Three Hundred United States Dollars) payable up to the 5<sup>th</sup> of each of the rentable month. For the month of January 2024 the amount will be paid up to 5 days upon signing the agreement"*

Through this Addendum, the Parties hereto agree that the **monthly rent payable under the Agreement shall be increased from USD \$1,300 (One Thousand, Three Hundred United States Dollars) to USD \$1,515 (One Thousand, five hundred fifteen United States Dollars)**. This increase shall apply to monthly rent starting from December 2024.

3. All other terms, conditions, and provisions of the Agreement shall remain in full force and effect, unchanged and unmodified by this Addendum.

4. The Parties acknowledge that this Addendum shall be published in the Czech register of contracts under Act No. 340/2015, on the register of contracts, as the Tenant is the liable person under this Act, and agrees to its publication. The Tenant shall ensure the publication within 30 days as of the signing of this Addendum by both parties.
5. **IN WITNESS:** whereof the Parties hereto have executed this Addendum as of the day and year first above written.
