### Ovid Technologies. Inc. Elsevier Products Addendum

This Addendum dated as of September 19th, 2024 supplements and amends the underlying Master Subscription Agreement, Master License Agreement or other existing agreement or order (collectively, "Agreement") by between Ovid Technologies, Inc. ("Ovid") and Licensee or Subscriber, as applicable ("Licensee/Subscriber") solely with respect to Licensee's/Subscriber's access to and use of Elsevier Products. Capitalized terms used herein without definition shall have the meanings ascribed to them in the Agreement. All terms and conditions of the Agreement remain in full force and effect and apply to the Elsevier Products except as expressly modified herein.

#### 1. **DEFINITIONS**.

The following definitions apply:

- "Authorized Users" shall mean only persons affiliated with a Licensee/Subscriber that permits such persons to access the Elsevier Products, including employees, currently enrolled full-time and part-time students, faculty, staff and researchers of the Licensee/Subscriber, healthcare professionals employed by the Licensee/Subscriber, library staff of the Licensee/Subscriber, walk-in users (while such walk-in users are physically present on the premises of the Licensee/Subscriber), and independent contractors or employees of independent contractors of the Licensee/Subscriber solely for the purposes of the contracted work performed by such independent contractors.
- **1.2 "Elsevier Products"** means Embase, Embase French Local Literature Module, Emcare, Emtree and/or GEOBASE.
- **1.2** "Permitted Use" means the limited access and use described in Section 2 "Authorized Uses of Elsevier Products"
- **1.3** "Platform" means Ovid's online platform.
- 2. AUTHORIZED USES OF ELSEVIER PRODUCTS.
- 2.1 Licensee/Subscriber will access and use Elsevier Products only for its internal purposes and in accordance with the authorized uses set forth in Section 2.2. For the avoidance of doubt, no other use is a Permitted Use.
- **2.2** Each Authorized User may:
  - access, search, browse and view the Elsevier Products on and through the Platform;
  - use the Elsevier Products for internal management, reference, education, research and training;
  - print, download and store a reasonable portion of individual items from the Elsevier Products for the exclusive use of such Authorized Users;
  - incorporate links to the Elsevier Products on Licensee/Subscriber's intranet and internet websites, provided that the appearance of such links and/or statements accompanying such links will be formatted in accordance with guidelines provided by Ovid;
  - provide print or electronic copies of individual items from the Elsevier Products (a) to governmental regulatory authorities for purposes of submitting applications for regulatory approval, trademarks or patents respecting Licensee/Subscriber's products or services; (b) when required by law for use in legal proceedings; and (c) to the individuals who are independent contractors or are employed by independent contractors of the Licensee/Subscriber without access to its network provided that (i) the copies will be used only for the purposes of the contracted work for the Licensee/Subscriber; (ii) the recipients are advised that the copies are not for redistribution or disseminati

at the termination of the contracted work, the copies will be destroyed;

- display or provide print or electronic copies of individual items from the Elsevier Products for the purposes of internal promotion and testing of the Elsevier Products and training groups of Authorized Users;
- solely for non-commercial purposes and within the Licensee/Subscriber's organization and only among those with authorized access to the Elsevier Products:
  - (a) incorporate limited portions of the Elsevier Products in printed and electronic (including Braille and other forms for the visually impaired) course packs, study packs, resource lists and in other materials (including but not limited to multi-media works) to be used in the course of instruction and/or in virtual and managed environments and allow for the perpetual retention thereof (including but not limited to virtual learning environments, managed learning environments, virtual research environments and library environments); provided, that each item shall carry appropriate acknowledgement of the source; and
  - (b) print and provide limited copies of the materials listed in paragraph (a) to others for purposes of Literature Review. For purposes of this authorized use, "limited portions" and "limited copies" means a quantity of records or results and/or a quantity of copies of materials containing those records or results that fall within the range for human-managed Literature Review according to the procedures of Licensee/Subscriber in conducting the Literature Review and/or that are necessary to satisfy industry or regulatory standards associated with the type of Literature Review conducted. "Literature Review" means an analysis, survey or exploration of existing sources, such as books, research papers, studies, journals, articles, data sets, bibliographic databases, scholarly literature and other materials, to provide a comprehensive overview of existing knowledge on a particular topic, inform research questions, guide the direction of future research, and/or continue to monitor the literature for new publications on the topic of research; and
- use stable URL links to the Platform placed in its course packs, research and other written and electronic materials that will permit access only and exclusively to and by Authorized Users to Elsevier Products on the Platform, including but not limited to links to conveniently permit access to prior searches and sessions involving Elsevier Products conducted by Licensee/Subscriber on the Platform. For the avoidance of doubt, access other than by Authorized Users will not be enabled to Elsevier Products on the Platform through the URL links.

# 3. RESTRICTIONS ON USE OF ELSEVIER PRODUCTS.

Licensee/Subscriber and its Authorized Users will not:

- redistribute the Elsevier Products;
- abridge, modify, translate or create any derivative work and/or service (including resulting from the
  use of artificial intelligence tools) based on the Elsevier Products, except to the extent necessary to
  make them perceptible on a computer screen to Authorized Users;
- remove, obscure or modify in any way any copyright notices, other notices or disclaimers as they
  appear in the Elsevier Products;
- use any robots, spiders, crawlers or other automated downloading programs, tools, or devices to search, scrape, extract, deep link, index or disrupt the working of the Elsevier Products;
- use the Elsevier Products in combination with an artificial intelligence tool (including to train an algorithm, test, process, analyze, generate output and/or develop any form of artificial intelligence tool);

- substantially or systematically reproduce, retain, store locally, redistribute or disseminate the Elsevier Products or parts thereof;
- use computational methodologies including performing searches and analyses, on individual items retrieved from Elsevier Products;
- post individual items from the Elsevier Products on social networking sites;
- share any data, insights or results gained from use of the Elsevier Products with a company providing a competitive product or service (including any affiliate, parent or subsidiary of Licensee/Subscriber); and
- for the Emtree Elsevier Product: incorporate the Elsevier Products, or any portions thereof, into other taxonomies or data structures.

## 4. PROTECTION FROM UNAUTHORIZED ACCESS AND USE.

The Licensee/Subscriber will:

- take appropriate measures to protect against non-Permitted Use, or misuse or unauthorized access, whether by the Licensee/Subscriber or any third party, through or to (a) the Licensee/Subscriber's credentials used to access the Elsevier Products; and (b) the Elsevier Products and/or information derived therefrom;
- manage identification, use, access and control of all credentials used to access the Elsevier Products in an appropriately secure manner, including, but not limited to, by: (i) limiting access to and use of the Elsevier Products to Authorized Users and notifying all Authorized Users of the usage restrictions set forth herein and that they must comply with such restrictions; (ii) issuing any passwords or credentials used to access the Elsevier Products only to Authorized Users, not divulging any passwords or credentials to any third party, and notify all Authorized Users not to divulge any passwords or credentials to any third party; and (iii) providing true, complete and accurate IP addresses, (if any) for the exclusive use by the Licensee/Subscriber (including, if requested, written confirmation by the relevant third party internet service provider). Nothing herein precludes an Authorized User from obtaining access to the Elsevier Products by remotely accessing the Platform through the Licensee/Subscriber facilities and systems;
- immediately deactivate any credentials when no longer needed or where access presents a security risk to the Elsevier Products;
- implement and maintain its own appropriate program for credentials management and ensure access to the Elsevier Products via such credentials is reviewed on an appropriate basis; and
- promptly upon discovering itself, or being notified by Elsevier or Ovid, that there has been unauthorized use of the Elsevier Products that presents a security risk to the Elsevier Products or an issue of unauthorized use of Elsevier Products, Licensee/Subscriber will take appropriate steps to end such activity and to prevent any recurrence, including, but not limited to, implementing required updates and configuration where needed to rectify the issue. When notified or upon discovering the unauthorized use directly, Licensee/Subscriber must promptly notify Elsevier and Ovid of the unauthorized use. Licensee/Subscriber will using industry standard practices cooperate with Elsevier and Ovid and share sufficient information, subject to any applicable confidentiality or nondisclosure obligations, concerning the unauthorized use or security issue.

# 5. SUSPENSION OF ACCESS TO ELSEVIER PRODUCTS.

In the event of any unauthorized use of the Elsevier Products, Ovid may suspend the access without notice to the Licensee/Subscriber. The Licensee/Subscriber will be responsible for the adherence to the terms and

conditions of this Addendum by any third party provider the Licensee/Subscriber engages, in particular, if such third party provider supplies and manages IP addresses.

#### 6. PRECEDENCE.

In the event of any inconsistency or conflict between the terms and conditions of this Addendum and the Agreement, the terms and conditions of this Addendum shall control.

#### 7. INTELLECTUAL PROPERTY

Licensee/Subscriber acknowledges that all right, title and interest in and to the Elsevier Products remain with Elsevier and its suppliers and that the unauthorized redistribution or dissemination online of the Elsevier Products could materially and irreparably harm Elsevier and its suppliers.

#### 8. DISCLAIMER

TO THE EXTENT PERMITTED BY APPLICABLE LAW, THE ELSEVIER PRODUCTS ARE PROVIDED "AS IS" AND ELSEVIER AND ITS SUPPLIERS EXPRESSLY DISCLAIM ALL WARRANTIES AND REPRESENTATIONS OF ANY KIND, INCLUSIVE BUT NOT LIMITED TO INDIRECT AND CONSEQUENTIAL DAMAGES, WITH REGARD TO THE ELSEVIER PRODUCTS AND ANY OTHER DATA, DOCUMENTATION OR MATERIALS PROVIDED IN CONNECTION WITH THIS ADDENDUM OR THE AGREEMENT, INCLUDING BUT NOT LIMITED TO ANY ERRORS, INACCURACIES, OMISSIONS, OR DEFECTS CONTAINED THEREIN, AND ANY IMPLIED OR EXPRESS WARRANTY AS TO MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE.

This Addendum may be signed in counterparts, all of which upon execution and delivery shall be considered originals and together shall constitute one agreement. Signed facsimile or portable document format (PDF) copies of this Addendum will legally bind the Parties to the same extent as original documents.
