In accordance with the clause XVI subclause 1 of the Framework contract for supplies of inks and auxiliary material for printing of banknotes, state documents and similar materials and forms and related services (No. 39/2018) concluded on 26. 4. 2018, as amended (hereinafter this version referred to as the „**Framework Contract**“) the Contracting Parties in accordance with the Act No. 134/2016 Sb., on public procurement, as amended, have agreed upon:

- a) the Annex No. 1 of the Framework Contract: Related Services, is updated in accordance with the section XVI paragraph 1 of the Framework Contract and replaced by the Annex No. 1 to this Amendment No. 9.
 - b) the Annex No. 2 of the Framework Contract: the Price list, is updated in accordance with the section V paragraph 4 of the Framework Contract and replaced by the Annex No. 1 to this Amendment No. 9. This updated Price list is valid for the year 2025.
2. The other provisions of the Framework Contract and its Annexes shall remain unchanged and in full force and effect.

III.

1. This Amendment No. 9 is drawn up in the English language in two copies with the validity of the original.
2. The Seller takes into consideration that this **Amendment No. 9** shall be published in the Register of Contracts pursuant to Act No. 340/2015 Coll., laying down special conditions for the effectiveness of certain contracts, the disclosure of these contracts and the register of contracts (the Register of Contracts Act), as amended. The publication shall be arranged by the Buyer.
3. This Amendment No. 9 comes into validity on the day of signature by both Contracting Parties and into effect after disclosing in the Contracts Register in accordance with the Register of Contracts Act.
