1.) Hereby Dorabella International Music Productions s.r.o. (short: Dorabella) engages the Moravská filharmonie Olomouc, p. o. (short: MFO) for a professional orchestra recording of opera arias and instrumental compositions, for all of which Dorabella or the soloists will bring the pertinent music (except for what is available in the archive of the orchestra, that can be used free of charge). Dorabella can bring as many soloists as Dorabella wishes.

2.) Moravská filharmonie Olomouc will provide the orchestra in the distribution of 51 musicians, professional hall (Philharmonic Concert Hall), freshly tuned piano, microphones, recording technics and technician. Dorabella provides soloists and conductor.

3.) The **recording sessions** will be on **June 30th and July 1st, 2025:**

30th of June 2025: 2 x 3 hours (10:00h - 13:00h and 14:30h - 17:30h)

1st of July 2025: 2 x 3 hours (10:00h - 13:00h and 14:30h - 17:30h)

Every aria (or music piece; also duettos and soundtracks are possible) shall be recorded at least twice, so that sufficient editing material is on the master tape or usb stick. Each of the artists (soloists) shall receive the full, uncut master tape (or usb stick) with the entire recording for further

cutting and editing. Each recording artist (soloist) will be exclusive owner of the recording and of all rights pertaining to it, for any sort of purpose. Moravská filharmonie Olomouc hereby transfers the rights entirely to Dorabella and the soloists. The soloists can freely and unlimitedly use the recording for their purposes.

The **piano rehearsal** with the soloists shall take place **on the 29th of June 2025 from 5pm to 9 pm.** Moravská filharmonie Olomouc shall put a room with piano for it at the disposal of Dorabella International Music Productions s.r.o., conductor and soloists.

4.) In case of the wish to use the name of Moravská filharmonie Olomouc for any uploading of the recording in the internet or other publishing of the recording, the soloist has to ask before this for the assentment of Moravská filharmonie Olomouc and present them the recording for their assentment.

5.) For all this (orchestra, place, technics, technician, microphones and hardware, work and rights), Dorabella International Music Productions s.r.o. shall pay to Moravská filharmonie Olomouc 1.500 euros per recording session (altogether 4 sessions, as above mentioned):

In total: 7.500,-€

(not subject to any additional payment, also no vat).

Dorabella International Music Productions s.r.o. retains the right to cancel the fourth and last recording session 1st of July 2025, 14:30h - 17:30h, by giving notice minimum three weeks before the beginning of the recording.

6.) The payment shall be effected upon presentation of invoice after the recording. Dorabella has the option to effect the payment by bank transfer.

7.) Slovak Law shall apply with Bratislava as convened venue.
