#### I. POINT OF AGREEMENT

The Buyer agrees to take over the Point of Agreement and to pay the Seller the agreed purchase price in the way and on the day as agreed in this Agreement.

## II. TERMS AND CONDITION OF SALE

The Seller undertakes to deliver the Point of Agreement defined in Article I of this Agreement no later than in 10 weeks from the date of effectiveness of this Agreement.

## III. PRICE AND TOTAL VALUE

1. The Buyer undertakes to pay the Seller a purchase price in the amount of:
