

**TŘETÍ DODATEK KE SMLouvĚ O KLINICKÉM
HODNOCENÍ**

Třetí dodatek („**Dodatek**“) ke Smlouvě o klinickém hodnocení uzavřené s účinností od 17. června 2020 a pozměněné Dodatkem č. 1 uzavřeného s účinností od 3. května 2022, Dodatkem č. 2 uzavřeného s účinností od 22. května 2024 (společně dále jen „**Smlouva**“), mezi **AbbVie s.r.o.**, Metronom Business Center, Bucharova 2817/13, Stodůlky, 158 00 Praha 5, Česká republika, IČ: 24148725, DIČ: CZ24148725, zastoupené Mgr. přednosta Interní hematologické a onkologické kliniky Fakultní nemocnice Brno („**Hlavní zkoušející**“) na poskytování služeb uvedených v Protokolu č. **M19-063** s názvem „**Randomizované, otevřené klinické hodnocení fáze 3 hodnotící bezpečnost a účinnost venetoclaxu v kombinaci s azacitidinem po alogenní transplantaci kmenových buněk u pacientů s akutní myeloidní leukemií (AML) (VIALE-T)**“.

S ohledem na řádné plnění tohoto Dodatku a v souladu s podmínkami Smlouvy, se smluvní strany dohodly pozměnit Smlouvu následovně:

1. Rozpočet stanovený v Příloze A Smlouvy a Dodatku 1, Dodatku 2 se zrušují v celém svém rozsahu a nahrazují se příloženou Přílohou A.

Pojmy, jež zde nejsou definovány jinak, mají stejný význam, který je jim připisován ve Smlouvě. Kromě podmínek, které se výslovně změnily tímto Dodatkem, zůstávají všechny ostatní podmínky této Smlouvy v plné platnosti a účinnosti během trvání této Smlouvy.

Tento Dodatek je sepsán ve třech vyhotoveních v českém a anglickém jazyce.

Tento Dodatek nabývá platnosti okamžikem podpisu všech smluvní stran a účinnosti okamžikem zveřejnění dle zákona č. 340/2015 Sb., o registru smluv.

**THIRD AMENDMENT TO THE CLINICAL STUDY

Jan Balzer, Country Clinical Operations Manager, based on Power of attorney („**AbbVie**“) and **Fakultní nemocnice Brno**, Jihlavská 20, 625 00 Brno, Czech Republic, ID: 652 69 705, VAT ID: CZ65269705, represented by MUDr. Ivo ROVNÝ, MBA, director („**Institution**“) and

Chief Physician of Internal Hematology and Oncology Clinic of Fakultní nemocnice Brno („**Principal Investigator**“) for services relating to Protocol No. **M19-063** entitled „**A Randomized, Open Label Phase 3 Study Evaluating Safety and Efficacy of Venetoclax in Combination With Azacitidine After Allogeneic Stem Cell Transplantation in Subjects With Acute Myeloid Leukemia (AML) (VIALE-T)**“.

Subject to the full execution of this Amendment and in accordance with the terms of the Agreement, the parties hereby agree to amend the Agreement, as follows:

1. The Budget set forth in Exhibit A of the Agreement and Amendment 1, Amendment 2 shall be deleted in its entirety and replaced with the attached Exhibit A hereto.

Terms not otherwise defined herein shall have the meanings ascribed to such terms in the Agreement. Except as specifically amended by this Amendment, all other terms and conditions of the Agreement shall continue in full force and effect during the term of the Agreement.

This Amendment has been made in three counterparts in Czech and English language.

This Amendment shall become executed upon its signing by all Parties and effective as of the day of its publishing in Contracts Registry, in accordance with Act no. 340/2015 Coll., on Contracts Registry, as amended.
