VI. Any changes of the lease scope and related services shall be reported in the Lease Report, which forms an inseparable part of this

VII. Lessee agrees to repay the amount for lease and related services in CZK as showed in the Article V of this Agreement.

VIII. Agreed payment schedule:

That they are familiar with the fact, that the real estate, which is subject of the lease is protected by the National Trust (cultural landmark) and therefore there is their obligation to follow terms and conditions of its use established by the Department of local development, investments and monuments preservation of the Český Krumlov Town Council.
- 2.To arrange for own operational staff on Lessee's own expense in case the Lessor's staff is not used.
- 3. On own expense to provide for posters promoting the event venue, date and time.

XII. Lessor has the right to withdraw from this Agreement providing Lessee or any other persons hired by Lessee seriously or repeatedly break the work and fire safety regulations, which Lessee were previously familiarized with. All parts of this contract i.e. Premises Lease Agreement, Premises Lease Related Services Agreement and agreed lease of other equipment i.e. sound system are legally interrelated in the sense, that if Premises Lease Agreement validity period terminates from any reasons then other related Agreements are terminated accordingly.

XIII. Lessee has the right to withdraw from this Agreement under extraordinary circumstances only i.e. unpredictable illness or force majeure circumstances. Under normal circumstances, if Lessee withdraw from the Agreement one month prior to the event is held, then 30 % of the total agreed amount shall be paid, when withdrawing from this Agreement 14 days before the event date, then 50 % of the total agreed amount shall be paid and when withdrawing 7 days before the event is held then 100% of the total agreed amount shall be
