

## PROCEDIA STRUCTURAL INTEGRITY AGREEMENT

Agreement made this 03/07/2025 04:06:23 by and between

ESIS European Structural Integrity Society with offices at Università di Cassino e del Lazio Meridionale ("Editor")

and

XXX(chairman), XXX (signer of the invoice) ("Organizer")

It is mutually agreed between the parties as follows:

- 1. The Organizers and the Editor agree that the Guest editors of the issue to be published in Procedia Structural Integrity (which shall be referred to hereinafter as "Procedia") are:

- 2. Event title and website: MSMF 11, <a href="https://www.msmf-brno.eu/?page=home">https://www.msmf-brno.eu/?page=home</a>
- 3. Dates of the conference: 23.6.2025 25.6.2025
- 4. Address of the conference: Brno University of Technology, Faculty of Mechanical Engineering, Technická 2896/2, Brno, Czech Republic
- All published Proceeding articles shall display the following text:
- "Peer-review under responsibility of XXX"
- 4. The Organizers will follow the reviewing process (selection of contributions, review and editing of manuscripts). The Editor will supervise the process.
- 5. The Organizers expect to submit about 30 papers.
- 6. The Organizers shall deliver the papers to the Editor before 30.09.2025. Elsevier (the Publisher) shall produce the Procedia as a separate issue in Procedia Structural Integrity and publish the same within 2 (two) months of receiving the final, complete and electronically formatted manuscripts in the English language. The Editor is not responsible for any delay in the publication date due to publishing problems.
- 7. The Organizers shall make all reasonable effort to ensure that: i) the Procedia are original and previously unpublished; ii) the Procedia contains no libellous, unlawful or otherwise actionable matter; (iii) the Procedia do not infringe on any copyright or violate any other intellectual property or privacy right of any person or entity; (iv) only papers presented at the MSMF 11 shall be delivered to the Publisher for publication as part of the Procedia.
- 8. Each paper in a Procedia issue shall consist of a minimum of 4 (four) pages and a maximum of 8 (eight) pages.
- 9. A fee of € 2,000 (Two Thousand Euros) applies, which will include the first 20 (twenty) papers. Additional papers above the first 20 (twenty) submitted papers, will be charged at a fee of € 30 (Thirty Euros) per paper. In case fewer than 50 (fifty) papers are submitted, a minimum fee of €



2,900 (Two Thousand Nine Hundred Euros) applies. The fees exclude any applicable taxes. The fees shall be paid to the Editor within 30 days after the end of the event organized by the Organizer. This cost is to be intended as a reimbursement of fees that will be paid by the Editor to the Publisher.

Only papers that strictly respect the template and have a sufficient scientific content will be published. It is responsibility of the Guest Editors to guarantee both the respect of the template and the high scientific standard of the papers.

ESIS retains the right to deny the publication to papers with a too low scientific level or out of topics for Procedia Structural Integrity.
