I.

1. The Contracting Parties concluded the above-mentioned Contract about supply and service of device for hot foil stamping, embossing and die-cutting on 17th March 2025 (hereinafter referred to as the „**Contract**“).
2. As a result of the Legal merger between Credit Suisse (Switzerland) Ltd. and UBS Switzerland AG, the transfer of client accounts to the successor company was initiated after the conclusion of the Contract and it is necessary to update the payment details in the Contract.
3. The Contracting Parties have agreed in accordance with the provision of Article XVIII, paragraph 4 of the Contract on the following changes to the Contract in accordance with the provisions of Sec. 222 of Act No. 134/2016 Coll., on public procurement, as amended:
 - a) The current wording of the Contract header in the Contractor's payment details section is replaced by the following new wording:

1. The other provisions of the Contract shall remain unchanged.
2. This Amendment becomes valid on the day it is signed by both Contracting Parties and takes effect once it is published in the Register of Contracts.

The Contracting Parties take into consideration that this Amendment shall be published in the Register of Contracts pursuant to Act No. 340/2015 Coll., laying down special conditions for the effectiveness of certain contracts, the disclosure of these contracts and the register of contracts (the Register of Contracts Act), as amended. The publication shall be arranged by the Client.
4. This Amendment is drawn up in English in two counterparts, out of which the Contractor shall obtain one counterpart and the Client shall obtain one counterpart.
5. The Contracting Parties declare they agree with the content hereof and this Amendment is prepared in a certain and intelligible manner, on the basis of true, free and serious will of the Contracting Parties, without any duress on either Contracting Party.
