Cooperation Agreement for the conference

"EARI Conference 2025 - Identity building in 20th century European Academia.

How political changes shaped the culture of remembrance of scientific institutions"

I. Purpose and subject of the agreement

- 1) The project partners will jointly design the conference and seek suitable scholars for the conference. On behalf of MUA CAS the responsible persons shall be [REDACTED] and [REDACTED] [REDACTED] (Prague), on behalf of Leopoldina-ZfW [REDACTED] and [REDACTED]. The selection of participants will be done by mutual agreement.
- 2) The project partners will publicly advertise the event and provide their logos and funding notes (i.e. relevant information on any conditions or limitations of their funds) for the programme and the call for papers.
- 3) Costs for travel to and from the conference, accommodation, catering and printing costs for promotional material will be paid by the institutes mentioned above, with MUA CAS (Lumina Quaeruntur research grant "Images of science" in Czechoslovakia 1918-1945-1968 and SAV21 Identities in the World of Wars and Crises) covering costs up to 6,400 EUR (travel, accommodation and catering) and Leopoldina-ZfW up to 3,000 EUR (travel, accommodation and catering). The exact distribution of the costs can still be modified by the organizing team in agreement with the management of the participating institutes and by written amendment to this contract. The

mentioned sums are considered as maximum expenses, which shall not be exceeded. Additional third-party funds may be raised.

4) The Masaryk Institute will be represented at the conference by at least one participant.

5) The event will take place at the MUA CAS on 2 June 2025 and at the main building of the Czech Academy of Sciences at Národní 1009/3 on 3-4 June 2025.

6) All institutions will be identified as cooperation partners on the conference programme and other publicity communications. MUA CAS and Leopoldina-ZfW will be in charge of promoting the event.

II. Final provisions

1) If either party fails to fulfil an obligation under this agreement, the party will cover all actual costs incurred by other parties to fulfil the subject matter of the agreement.

2) This agreement shall enter into force on the day of its publication in the Czech Contract Register. The publication shall be carried out by the MUA CAS immediately after the contract is signed by the last party.

3) Amendments and additions may be made only in the form of written amendments, signed by all parties.

4) This agreement has been prepared in two equivalents, each with the validity of the original. Each of the contracting parties shall receive one copy upon signature.

5) If any dispute arises out of this agreement, the parties agree to seek non-litigious means to resolve them. Partners shall attempt to resolve any dispute or misunderstanding through collaboration. In the unlikely case the dispute remains unresolved, it shall be resolved by the competent jurisdiction of the defendant.

6) The agreement is governed by the law of the Czech Republic
