### **Article 1**

- 1.1. On 13 December 2024, the contracting parties concluded an agreement concerning the implementation of specific activities within the project "Support to the Food Safety and SPS Sector in Georgia under ENPARD IV" and "Better Goods and Servicesin Georgia", focused on organizing language courses for employees of Georgian food/agricultural laboratories and other entities. The contracting parties have agreed on the following amendments to the contract.
- 1.2. The contracting parties have agreed to amend Article 1, paragraph 1.2 due to personnel changes: The following authorised person is authorised to act on behalf of the Client in relation hereto: Jonáš Háger, tel.: email: (ENPARD), Blanka Michaela Remešová, email: (QuIS).
- 1.3. The contractual parties have agreed to adjust the number of course participants to 185, which leads to an increase in the number of teaching materials and therefore also an increase in the total price by USD 625. The contractual parties have also agreed to change the number of classes to a new total of 11.

Article 2, paragraph 2.1 of the Contract shall now read as follows:

The Client shall pay the Contractor the amount of USD 55 (in words: fifty-five) for each completed language lesson (120 minutes) per class. The Client shall pay the Contractor USD 25 (in words: twenty-five) for each set of teaching materials delivered to the participants of the language course.

No VAT shall be charged, as the project is registered in Georgia with the Revenue Service as VAT-exempt.

The maximum contractual price for the fulfillment shall be the sum of the cost of all



# General objectives, target group, venue

Language skills presents a significant barrier to innovative work due to the inability of laboratory staff to read and understand scientific manuscripts, regulations and standards/methods in the English language. Therefore, the language barrier negatively affects laboratory performance and may have indirect impact on the test results.

Improving English language skills will enhance state entities' performance in international relations and experience sharing.

English language courses may remedy the gaps in language skills and contribute to better understanding and use of English: general as well as professional terminology.

# Specific objectives – tasks for selected service provider:

- Objective 1: Identification and Organization of Participants (November 2024)
  - Task: Coordinate with CzDA and partner organizations (NFA, MEPA, RS, SLA, GeoSTM) to receive a list of approximately 185 potential training participants, including relevant contact information.
  - Task: Organize participants into three groups based on their organization of origin:
    - Group 1: NFA, MEPA, EIEC and RS employees.
    - Group 2: SLA employees and employees of other food-agri labs.
    - Group 3: GeoSTM employees.
- Objective 2: Conduct Initial Meeting and Pre-Test (January 2025)
  - o **Task**: Arrange and conduct an initial meeting with all three groups.
  - Task: Administer the Pre-Test (pre-approved by CzDA) to assess participants' current language proficiency levels.
  - o **Task**: Present and introduce the selected training methodologies to the participants, ensuring these are pre-approved by CzDA.
- Objective 3: Group and Class Assignment Based on Pre-Test Results (January 2025)
  - Task: Evaluate the Pre-Test results and classify participants into three levels: Beginners, Pre-Intermediate, and Intermediate.
  - Task: Assign participants to classes based on their proficiency level, ensuring a maximum of 20 participants and a minimum of 5 per class.
- Objective 4: Second Meeting to Finalize Class Schedules and Provide Training Materials (February 2025)
  - o **Task**: Hold a second meeting with all three groups to:
  - o Present Pre-Test results and assign participants to specific classes.
  - Confirm the schedule (weekday/time) and location of the training sessions in consultation with participants and CzDA.
  - o Introduce participants to their respective trainers.
  - o Distribute printed training materials approved by CzDA.

# • Objective 5: Conduct Training Sessions (March 2024 – October 2025)

- Task: Deliver 728 training sessions. Distribute this number among 11 classes<sup>1</sup>,
   following the selected and CzDA-approved methodologies.

## **Timeframe**

The expected duration of Onsite English Language Course is January 2025 – October 2025, included design and delivery of Pre-test/Mid-test after 4 months and Exit-test after 8 months providing English language course and internal certification upon completion of respective tests:

**Indicated Timeframe includes:** 

- Preparational works and delivering of Pre-test, and Mid-test and Exit-test
- Division (or distribution) of participants of each group into appropriate classes at the level determined by the Pre-test;
- 8-months long course itself.

# Mode of planning of language courses:

Mode of planning of language courses with Georgian state authorities (NFA, MEPA, RS, SLA, GeoSTM, EIEC) and private Food/Agri Laboratories. The relevant classes of the training course should be planned in agreement with the relevant Georgian state authorities (in particular, with the participants of the training) and CzDA, according to the following scheme:

- ➤ Each partner organization (NFA, MEPA, RS, SLA, GeoSTM, EIEC) will provide CzDA and the service provider with a list of potential training participants from their side with relevant contact information, around 185 employees January 2025;

CzDA) to determine the level of their knowledge; will also introduce the selected (agreed with CzDA) training methodologies. – January 2024;

- > The service provider will then evaluate the test results and divide participants into three levels beginners, pre-intermediate and intermediate, according to the level determined by the Pre-Test. Then the service provider will divide them into particular classes. January 2025:
- Each class will have maximum of 20 participants and minimum of 5, divided by their group of origin and level; **max. 11 classes** in total for all 3 Groups (Group 1 max 5 classes, Group 2 max. 3 classes, Group 3 max. 3 classes)
- > The Provider will deliver a total of 728 training sessions, distributed across 11 classes. The distribution of sessions will be proportional. However, if this is not feasible, the schedule will be adjusted as necessary to meet operational requirements.
- ➤ Ideally, the distribution of sessions will be proportional. However, if this is not feasible, the schedule will be adjusted as necessary to meet operational requirements. The service provider, with coordination of CzDA, will hold a second meeting with the 3 groups where they will introduce the results of the Pre-Test, the composition/members each class, and agree with the participants on the place and time (weekday/time) of the training sessions at the time and place preferred by the participants. Also, each class will be introduced to the relevant trainer and will be given printed training material February 2025;
- ➤ The service provider will conduct training sessions according to selected (and approved by CzDA) methodologies 2 training sessions a week. Each training session will last for 120 minutes. Duration 8 months at the place and time selected by the participants, which should be approved by the CZDA February 2025;
- At the end of the 4<sup>th</sup> month of the training course, during 1 training session, the service provider will conduct Mid-test for the participants, according to the results of which, each participant will receive an internal certificate. # Mode of cooperation with CzDA:

CzDA's responsibility will be mainly to supervise the implementation of the assignment.

At the beginning, details on the practical organization of the courses, including the list of participants, the place (in Tbilisi) and the week days and time of the classes should be agreed with CzDA.

The communication language with CzDA is English.

### **Scope of work:**

The service provider is expected to deliver onsite English language course at Beginner/Preintermediate/Intermediate levels to employees of the Project partner state authorities (NFA, MEPA, EIEC, RS, SLA, GeoSTM) and Food/Agri Laboratories in Georgia. Upon completion of the courses, the service provider will organize internal certificated exams to establish whether the students have gained the specific level of English language competence to be accordingly validated with a certificate.

The main learning outcomes of the service will be:

- Development of basic/intermediary English language reading skills in a General context, with possible consideration of Regulatory and Laboratory specifics in the fields of food safety/agriculture/quality infrastructure;
- Development of basic/intermediary English language listening and speaking skills in a General context, with possible consideration of Regulatory and Laboratory specifics in the fields of food safety/agriculture/quality infrastructure;
- Development of basic/intermediary English language writing/mailing (incl. official)/report-writing skills/techniques in a General context, with possible consideration

of Regulatory and Laboratory specifics in the fields of food safety/agriculture/quality infrastructure;

• Development of basic/intermediary English language research/searching skills in a General context, with possible consideration of Regulatory and Laboratory specifics in the fields of food safety/agriculture/quality infrastructure.

The above learning outcomes will enhance beneficiaries' skills to review, understand and comment on documents (regulations/standards/methods) in English language, prepare official correspondence and reports in English language and communicate effectively with international counterparts. Additionally, they will contribute to strengthening employees' capacities to access knowledge pertaining to their work through internet and media, as well as be able to effectively use English language in basic professional verbal interaction.

The language course delivery will be group-based and delivered fully onsite (face-to-face), during working days, with frequency of 2 hours lesson/training session - twice per week.

The service provider is expected to keep attendance records of each class and submit them to the CzDA upon completion of each of the courses' modules. Details on practical organization of the courses, including the place (in Tbilisi) and the week days and time of the classes, will be agreed jointly between the service provider, beneficiaries and CzDA.

The expected timeframe for the service delivery is from November 2024 to October 2025.

# Main Requirements which will deem the offer technically responsive and selection criteria:

- Institutional experience: The offeror must be registered in Georgia as legal entity or individual entrepreneur (Representing and leading the group of trainers); Legal entity should have minimum of three years of operation in the fields of English language teaching/training;
- Relevant expertise: The proposed trainer(s) must have demonstrated expertise in delivery of English language training and a minimum of 3 years of relevant working experience;
- Delivery modality flexibility: Readiness and capacity to provide training to beneficiaries at their own schedule within working week and place with consent of CzDA;
- Modern teaching methods: The service provider must provide/prepare comprehensive training packages (including relevant supporting materials/books/literature, presentations, group exercises, additional reading materials, homework material, etc. mainly in printed format, but also can include online/digital content), while key learning messages are to be provided during lessons and reinforced with the use of visual presentations and handouts if needed.
