## Delivery

- 1. The pre-plated Library (hereinafter, the "Library") will be delivered to the place indicated by Client under DAP Incoterms.
- 2. Enamine will invoice only such Library that has been delivered and accepted by Client or its duly appointed representative.

#### Limited use

- The use of the Library is subject to the Client's acceptance of the terms and conditions of this Quotation. If Client does not accept these terms, then the Client shall not issue a purchase order for the supply of this Library.
- 7. The purchase of the Library conveys to Client a non-transferable right to use the purchased quantity of the Library compounds for its Own Research Use ("ORU") only. In this Agreement, ORU means any Client research activity performed to obtain novel chemical matter derived from the use of Enamine Library compounds provided under this Agreement.
- 8. As a material condition of Enamine providing the Library to Client, Client shall not, directly or indirectly, use the Library for any purposes other than ORU and only then in accordance with the terms of this Quotation. Enamine acknowledges and agrees that the Client will use the Library for the purposes of generating or creating compounds intended for commercialization, and hereby is authorized to utilize the Library for the purposes of generating a compound for sale and shall not be restricted from commercializing a product using the Library.
- 9.
