**HAVE AGREED**

**1 Subject matter**

- 1.1 This specific contract implements framework contract (FWC) No F-SE-22-T01-L03-C01 - Czechia, signed by the contracting authority and the contractor on 12/12/2022.
- 1.2 The subject matter of this specific contract is services related to the project SR 52 *"Research analysis and reporting on fundamental rights considerations on asylum, border and migration – quarterly reports."*
- 1.3 The contractor undertakes, in accordance with the terms set out in the FWC and in this specific contract and the annexes thereto, which form an integral part thereof, to perform the tasks specified in ANNEX I to the specific contract.

## **2 Entry into force and duration**

- 2.1 This specific contract shall enter into force on the date on which it is signed by the last party.
- 2.2 The duration of the execution of the tasks shall not exceed **17 November 2025**. Execution of the tasks shall start from the date of entry into force of this specific contract.

The period of execution of the tasks may be extended only with the express written agreement of the parties before such period elapses.

## **3 Performance and location**

- 3.1 The tasks performed by the contractor under this specific contract shall result in deliverables, defined according to the provisions of ANNEX I to the specific contract.

Signature by the contracting authority of the Task Acceptance Form attached in ANNEX III to the specific contract shall provide evidence of the work performed.

- 3.2 The tasks shall be performed at the contractor's premises, unless otherwise specified in ANNEX I to the specific contract.

## **4 Price and payments**

- 4.1 The contracting authority undertakes to pay the contractor, in consideration of the services actually rendered under the specific contract, in accordance with the breakdown included in Annex II. If the number of days agreed has not been fully taken up, the contracting authority shall not be obliged either to use or to pay for the days not worked and the contractor shall not be entitled to claim damages for them.
- 4.2 The maximum total price to be paid under this specific contract shall be **EUR 6,705.00** covering all tasks executed. This amount shall cover all expenditure incurred by the contractor in performing this specific contract. No reimbursable expenses are foreseen.
- 4.3 In conformity with Articles I.5 and I.6 of the special conditions and II.21 of the general conditions of the FWC, the invoicing procedures for the services, once accepted by the contracting authority, are as follows:

- 100% on completion of the work, based on a Tasks Acceptance Form signed by the contracting authority in accordance with the form in Annex III (to be attached to the invoice).
- 4.4 Payments shall be made to account No CZ23 0710 0000 0000 6882 3011 held with Česká národní banka - ČNB on production of the invoice showing separately the amount of the services and the VAT applied and within no more than 60 calendar days from the date the invoice is received by the unit indicated in article 4.5 below. Invoices presented by the contractor shall indicate its place of taxation for VAT purposes and shall specify separately the amounts not including VAT from those amounts including VAT. The payment shall be deemed to have been effected on the day the contracting authority's financial account is debited.
