CONTEXT AND RATIONALE

Context:

Goal: Business Plan of Millie Bus. Proposing institutional and financial arrangements for governmental and private sector working directly in bus transport of Kabul city.

Problem: Currently, Millie Bus enterprise—which is a public utility organization—provides limited public transport services to the general public. Total of 96 (15%) national buses out of 624 are running on designated routes. The rest of the buses are not in working condition due to the lack of an effective management.

Expected outputs and outcomes:

Business Plan of MiliBus Enterprise should include:

a) Operational plan: The operational plan should identify best options on bus ownership, bus services, bus management, fare management & collection, bus depots & sleeping grounds, maintenance of buses, fuel sources, bus branding & external advertising, and bus governance (policy and decision makers).



- b) Institutional restructuring: Currently Proving Public Transport Infrastructure is related to Kabul Municipality, and Operational Management is related to Ministry of Transport and Civil Aviation.
- **C)** Financial model and Appraisal: Public Private Partnership options (approved by Afghanistan law) should be evaluated and prioritized.
- d) Social and Environmental Assessment: Currently, Public transport dedicates nearly 50% of the transport share, in addition the public transport is highly relying on private small vehicles. The mode shift from small vehicles to high demand buses with their social and environmental effects should be utilized.
- e) Implementation Timeframe: The transition timeframe and implementation resources should be stated based on realistic mind-set.
