

Partnership Agreement

This agreement ("Partnership Agreement") is made between the:

UNIVERZITA KARLOVA (CU) with legal address Ovocny trh 560/5, 116 36, Praha 1, Czech Republic, legally represented by doc. RNDr. Ing. Vladimír Krylov, PhD., Dean of the Faculty of Science hereinafter referred to as "Contractor" as a Party of the ESA Contract No. 4000145896/24/I-KE hereinafter referred to as "Charles University" and

The ignite education whose registered office is at Am Steinborn 2, 07749 Jena, Germany.

Hereinafter referred to as "ignite education"

Subject:

- On 6/28/2024, the Faculty concluded a contract with The EUROPEAN SPACE AGENCY (hereinafter called the "ESA"), marked „ESA Contract No. 4000145896/24/I-KE
- " (hereinafter the "Contract"). The subject of the Contract is to perform the TRAINING ACADEMY FOR EO EDUCATION SUPPORT - EXPRO+ " activity (all hereafter referred to as the "Work") and to deliver all the items listed in ARTICLE 2 of the Contract.
- ignite education is listed as a Subcontractor in the Contract
- ignite education declares that he is familiar with the Contract including its annexes
- ignite education undertakes to provide the Charles University with performance to the extent corresponding to his share of the Work. ignite education's contribution to the Work is described in the section 2.8 Technical Implementation/Programme Of Work of the Detailed Proposal of the project submitted as part of the tender proposal in an extent defined by PSSA8 form provided by ignite education for the proposal (all hereafter referred to as the "Part of the Work").
- The Charles University undertakes to pay for the performance of its Part of the Work the remuneration specified in the Contract and in the manner specified in the Contract
- ignite education undertakes to act in accordance with the conditions set out in the Agreement when dealing with money provided by ESA
- ignite education also undertakes to comply with the conditions for MANAGEMENT AND CONTROL OF INVENTORY ITEMS/FIXED ASSETS
- ignite education undertakes to enable an audit by ESA or an ESA designated person and cooperate with the ESA's investigation team
- ignite education undertakes to fulfil his Part of the Work in accordance with the Contract and to provide Charles University with cooperation to a sufficient extent and at times or deadlines so that the Charles University can fulfil its obligations towards ESA
- Handling of the results of the Part of the Work will be governed by the Contract.
- Any work created within the framework of this Agreement of which one party is the author or holds the intellectual property rights will remain the sole property of that party, with the other parties having a licence to use that work for the purposes of this agreement.
- ignite education undertakes to fulfil obligations stipulated by the Contract, if this is necessary for the fulfilment of the Part of the Work

- ignite education undertakes to maintain confidentiality to the extent set forth in the Contract
- Relations not addressed by this contract are governed by the Contract; in particular place and date of delivery, termination of the contract, obligation to return money, conditions of publicity, information about the progress of work, withdrawal of money, protection of personal data, liabilities, ESA rights to use the results arising from Work. This list is exemplary, not exhaustive.
- ignite education acknowledges that Charles University has a legal obligation to disclose this Agreement
