<u>Úvodní ustanovení</u>

1. Smluvní strany uzavřely dne 26.3.2025 smlouvu o dílo, jejímž předmětem je realizace dílčích aktivit projektu "Support to the Food Safety and SPS sector in Georgia under ENPARD IV" zaměřených na podporu rozvoje gruzínského laboratorního sektoru v oblasti laboratorní kontroly kvality přípravků na ochranu rostlin (dále jen "smlouva").
