## ERASMUS MUNDUS EUROCULTURE CONSORTIUM

## SCHEME for FEE DISTRIBUTION 2023-2025/ 4th semester

## AGREEMENT

It is hereby agreed upon that the following payments will be made in the context of the Erasmus Mundus Joint Master Programme (EMJMD) Euroculture for 2023-2025: 4th semester. The amounts are based on the agreed amounts as laid down in the Financial Agreement Euroculture 2023-2025. Payment of future semester fees will be arranged for in upcoming payment agreements, pending the choices of the respective students of where they will study in those semesters.

The University of Groningen, as Chair of the Euroculture Consortium, has collected the tuition fees for self-financing EU and non-EU students studying in the Consortium, as well as for EM scholarship holding students. For EM scholarship-holding students, it has been agreed that each university will receive an equal share of fee money obtained from the European Commission irrespective of where the student spends the 1<sup>st</sup>, 2<sup>nd</sup>, 3<sup>rd</sup> and 4<sup>th</sup> semester through the **Basket of Fees** model. The amount that is to be distributed across the European partner universities will be calculated per year (year 1 and year 2) and will be based on the incoming fees of EM scholarship holding students divided by 8 and with deduction of the third-country mobility.

## Fees for Erasmus Mundus grant-holding students for 2023-2025:

Fee payments related to Erasmus Mundus grant holders for the cohort 2023-2025 are transferred to each partner university at the start of every academic year. Considering that this concerns an agreement for the 4th semester of this cohort, no funds will be transferred as part of the Basket of Fees at this time.

The University of Groningen will pay to the Univerzita Palackého v Olomouci the total amount of  $\bigcirc 937,50$  covering the fees for the 4th semester of group 2023-2025. The total amount to be paid to the Univerzita Palackého v Olomouci can be broken down as follows:
